<u>Sub:</u> Permission for shifting of premises to new location/building pertaining to Gnana Bharathi D.Ed College, Davanagere, Karnataka from Vinayaka Extension, 3rd Main, Near Vidyanagar, Davanagere – 577 004, Karnataka to #1638/8, Chigateri Towers, Hadadi Road, Taralabalu Nagara, Davanagere, Karnataka

Preamble:

Gnana Bharathi D.Ed College, Vinayaka Extension, 3rd Main, Near Vidyanagar, Davanagere – 577 004, Karnataka has been granted recognition by SRC for offering D.Ed course from the academic session 2005-2006 with an intake of 50 students on 24.12.2005.

The State Government of Karnataka in its letter addressed to Ministry of HRD, Government of India, New Delhi and NCTE has recommended for withdrawal of recognition of some institutions in the state of Karnataka as the institutions are lacking infrastructural, instructional facilities and staff.

The matter was placed before SRC in its 134th meeting of SRC held during 29-31 May and 1 June,2007. The Regional Committee has decided to cause inspection of the institutions recommended for withdrawal of recognition by state Government of Karnataka under Section 17 of NCTE Act,1993 to verify the veracity of the objections raised and also the facilities provided by the institutions as per norms & standard prescribed by NCTE.

Accordingly, an inspection team was constituted by SRC-NCTE which visited the above institution on 10.08.2007. The report of the inspection team was placed before the Southern Regional Committee in its sub committee meeting of SRC held on 24th August,2007. The SRC considered the VT report, VCD, original file and other documents submitted by the institution and decided to issue notice under section 17. Accordingly, notice was issued to the institution on 05.09.2007.

The Written representation of the institution submitted on 20.09.2007 was placed before SRC in its 146th meeting held on 25-27th October 2007 and decided to continue recognition for the year 2007-2008 only subject to removal of the following deficiencies.

- The built up area is 9449 sq.ft and it is shared with Modern School
- The sizes of all rooms are not as per norms.

Accordingly, a letter to the institution has been issued on 10.08.2009. As the institution has not submitted any reply to the letter, the matter was placed before SRC in its 189th meeting held on 25-26 February 2010 and SRC decided to issue notice. Accordingly, notice was issued to the institution on 07.04.2010. The institution submitted its written representation on 26.04.2010.

SRC in its 192nd meeting held on 10-11 May 2010 considered the matter and decided to withdraw recognition of the institution for the D.Ed. course for the following reason.

The institution has shifted to a new location other than the one originally permitted in violation of norms and regulations.

Further, the SRC decided that the withdrawal takes effect from the academic session 2011-12 in order to enable the ongoing batch of programme to be completed. However, no more fresh admissions shall be made after the date of the order of withdrawal.

Accordingly, order for withdrawing recognition was issued to the institution on 29.06.2010.

The institution moved Hon'ble High Court of Karnataka in W.P.No.22681 of 2010 and the court has considered the request made by the petitioner regarding consideration of its appeal on or before 13.08.2010 and was accepted. The respondent Appellate Authority was directed to consider and decide the appeal before 13.08.2010.

The institution in its letter dated 16.08.2010 has enclosed the Appellate Authority order dated 13.08.2010 for restoring of recognition, wherein the Appellate Authority reads as follows:

"..... remand back the case to SRC with a direction to cause an inspection of the institution at the new premises and take further action. In the meantime, the SRC should restore recognition to the appellant institution immediately within 15days of issuing the appellate order."

The SRC in its 195th meeting held on 17-18 August 2010 considered the matter and decided to continue recognition as per the appellate authority order and it was also decided to cause inspection to the institution under section 17 on payment of Rs.40,000/-. The institution had already made payment on 13.07.2009. As per the decision of SRC, the recognition of the institution was restored vide order dated 02.09.2010.

Further, as per the decision of SRC, inspection was carried out between 9 -10 September 2010 for shifting of premises. The inspection report was placed before SRC in its 197th meeting held on 13-14 October 2010 and decided to continue recognition accorded to the institution. Accordingly, as per the decision of SRC, the file was put up and it has been observed that the SRC has not conferred its decision regarding shifting of premises. Hence, once again the details of the visiting team report for shifting of premises was placed before SRC in its 199th meeting held on 22-23 December 2010. SRC considered the matter and decided to permit for shifting of premises to Gnana Bharathi D.Ed College, Davanagere, Karnataka from Vinayaka Extension, 3rd Main, Near Vidyanagar, Davanagere – 577 004, Karnataka to #1638/8, Chigateri Towers, Hadadi Road, Taralabalu Nagara, Davanagere, Karnataka

Hence the order.

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Sri.Naradamuni Educational Welfare Institution, 1st Floor, Sri.Murugharajendra Complex, Hadadi Road, Davanagere – 577002, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Gnana Bharathi D.Ed College, Vinayaka Extension, 3rd Main, Near Vidyanagar, Davanagere – 577 004, Karnata ka for conducting D.Ed course with an intake of 50 students on 31.12.2003.

 AND WHEREAS the institution has been granted recognition from the session 2005-2006 from the session 2005-2006 vide order No.F.SRO/NCTE/D.Ed/2005-2006/4949 dated 24.12.2005. Further, the recognition of the institution was withdrawn vide order dated 29.06.2010.

3. AND WHEREAS the SRC in its 195th meeting held on 17-18 August 2010 considered the court order as well as the Appellate Authority order and decided that the recognition be continued as per Appellate Authority order and to cause inspection to the institution under section 17 of NCTE Act on payment of Rs.40,000/-.

AND WHERES inspection was carried out between 9-10 September 2010. SRC in its 197th meeting held on 13-14 October 2010 considered the VT report, VCD and other related documents along with the original file of the institution and decided to continue recognition accorded to the institution. Accordingly, as per the decision of SRC, the file was put up and it has been observed that the SRC has not conferred its decision regarding shifting of premises. Hence, once again the details of the visiting team report for shifting of premises was placed before SRC in its 199th meeting held on 22-23 December 2010.

5. AND WHEREAS SRC considered the VT report along with original file and decided to permit Gnana Bharathi D.Ed College to shift the premises from Vinayaka Extension, 3rd Main, Near Vidyanagar, Davanagere – 577 004, Karnataka to #1638/8, Chigateri Towers, Hadadi Road, Taralabalu Nagara, Davanagere, Karnataka

Permission is hereby accorded by SRC to Gnana Bharathi D.Ed College to shift the premises to the new location / building at #1638/8, Chigateri Towers, Hadadi Road, Taralabalu Nagara, Davanagere, Karnataka under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:

- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations,2007.
- III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
- 7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - (i) Copy of the Application Form
 - (ii) Land and Building Particulars
 - (iii) Staff Profile
 - (iv) Recognition letter
 - (v) Information for having fulfilled the norms & standard and other required conditions.
- 9. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
