- exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Equation (NCTE) Act, 1993, the Southern Regional Committee grants recognition to Covernment Pre-Primary Teacher Training Institute, Eranhipalam-673006, Kozhikode District, Kerala for Pre-Primary course of one year turation from the academic session 2000-2001 with an annual intake of 50, subject to Tuffing the following conditions:

- such teachers already appointed who do not fulfil the NCTE norms shall acquire the that foations as per the norms within a period of two years of this order.
- Educational / professional journals should be subscribed as per NCTE norms.
- assitution shall ensure library, laboratories and other instructional infrastructure as per the NOTE norms.
- The admission to the approved course shall be given only to those candidates who are eligible so cer the regulations governing the course and in the manner laid down by the affiliating - - ersity / State Government as the case may be.
- Tuton fee and other fees will be charged from the students as per the norms of the affiliating - resity / State Government as the case may be till such time NCTE regulations in respect of fee structure come into force.
- Curroulum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the affiliating University / examining body as the case may be.
- Teaching days including practice teaching should not be less than the number fixed in the CTE norms for the course.
- The Institution, if unaided, shall maintain endowment and reserve fund as per NCTE norms.
- The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If Government Pre-Primary Teacher Training Institute, Eranhipalam-673006, Kozhikode District, Kerala contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
