ORDER

WHEREAS, Gnanodaya Educational Society, Metapally Post Mandal, Karimnagar District-505325, Andhra Pradesh has applied for grant of recognition to Gnanodaya HPT College, Sy.No. 1335/A, Balakrishna Nagar, Munsif Court, Metapally, Karimnagar District-505325, Andhra Pradesh for H.P.T course to Southern Regional Committee, NCTE, Bangalore on 27.12.2001.

AND WHEREAS, the application was processed and after considering the report of the Visiting Team as well as other relevant materials granted recognition to the institution for offering HPT course with an intake of 50 students vide order No.2557 dated 22.08.2002.

AND WHEREAS, the institution in its letter dated 28.12.2008 has submitted proposal for shifting the HPT course to the new location.

AND WHEREAS, the Southern Regional Committee in its 204<sup>th</sup> Meeting of SRC 27<sup>th</sup> – 28<sup>th</sup> April, 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve the Show cause Notice. As per the decision of SRC Show Cause Notice was issued to the institution on 25.05.2011. institution has submitted its written representation on 25.05.2011.

AND WHEREAS, the Southern Regional Committee in its 211<sup>th</sup> Meeting held on 21<sup>st</sup> – 23<sup>rd</sup> of 2011 considered the reply of the institution dt. 25.05.2011 and decided to cause Re-inspection of the institution on submission of Rs. 40000/- towards inspection fee for the course being run, under Section 17 of NCTE Act.

AND WHEREAS, the Southern Regional Committee considered in its 215<sup>th</sup> meeting held on 12<sup>th</sup>-13<sup>th</sup> December, 2011 considered the VT Report, VCD and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act.

AND WHEREAS, accordingly, a show cause notice was issued to the institution on 03/02/2012. The institution has submitted written representation on 11/04/2012.

AND WHEREAS, the Southern Regional Committee in its 222<sup>nd</sup> meeting held on 9<sup>th</sup> to 10<sup>th</sup> May, 2012, considered the reply of the institution vide letter dt. 11.04.2012 and all the relevant documentary evidences and it was decided to serve Final Show cause Notice under section 14 (1) of NCTE Act. Accordingly, a Final Show Cause Notice was issued on 11/06/2012. The institution has submitted its written representation on 28.06.2012

AND WHEREAS, the SRC in its 228<sup>th</sup> meeting held on 24<sup>th</sup>-25<sup>th</sup> July, 2012 considered the reply of the institution vide letter dt. 28.06.2012 and all other relevant documentary evidence and decided to allow for shifting of the institution to the new premises.

NOW THEREFORE permission is hereby accorded by SRC to Gnanodaya HPT College, C/o Sri Suryodaya High School, Karim Nagar, Metapally- 505325, Andhra Pradesh to shift the premises to the new location / building at Gnanodaya HPT College, Bala Krishna Nagar, Near Munsif Court, Metapalli- 505325, Andhra Pradesh.

If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
