WHEREAS, Sri Andal Educational Cultural Society, Hyderabad, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Gandhian College of Education, No.5-67, Umberper Road, Kuntloor, Hayat Nagar, Ranga Reddy District-500035, Andhra Pradesh for Secondary (B.Ed) course of one year duration with an annual intake of 100 (Hundred) students and was granted recognition on 27.08.2007.

AND WHEREAS, a letter dated 14.11.2014 was received by this office on 17.11.2014, from the Chairman, Sri Andal Educational Cultural Society, Ranga Reddy District, Andhra Pradesh requesting permission for building expansion to Sri Andal Educational Cultural Society, Gandhian College of Education, H.No.5-67, Peddamberpet Road, Kuntloor Village, Hayath Nagar, Ranga Reddy District, Telangana State-501505. On 17.11.2014, a letter was issued to the institution stating that the request for inspection will be considered after formulation of new Regulations.

AND WHEREAS, in the meantime, the institution has approached the Hon'ble Court in W.P.No.37094 of 2014 with a prayer for declaration of the action of the second respondent (The Osmania University) passing the order rejecting the affiliation to Gandhi College of Education based on the observations of the inspection Committee of the University

**AND WHEREAS,** on 26.12.2014, a Court order dated 03.12.2014, is received by this office from the Hon'ble High Court of Judicature at Hyderabad for the States of Telangana and the State of Andhra Pradesh. Wherein SRC, NCTE is the 3<sup>rd</sup> respondent in WP No.37094 of 2014 as under:-

"Mr. Satyanarayana Goud, learned counsel representing Mr. K. Ramakanth Reddy, learned Standing Counsel for respondent No.3, seeks time for filing counter-affidavit. None appears for respondent No.2. Therefore, notice to the said respondent. Personal service is permitted. Post on 29.12.2014.

Pending further orders, respondent No.2 shall receive the list of students for B.Ed

AND WHEREAS, the institution has submitted a D.D. No.610435, of Rs.50,000/-, dated 05.01.2015 drawn in favour of the Regional Director SRC, NCTE, payable at Bangalore towards shifting fees.

AND WHEREAS, the Southern Regional Committee in its 278<sup>th</sup> meeting held during 25<sup>th</sup> Januar, 2015 considered the matter and decided to issue Show Cause Notice for inadequate and area approved building plan and building completion certificate.

AND WHEREAS, on 09.02.2015 the institution has submitted its written representation based on the decision available from NCTE website

AND WHEREAS, the Southern Regional Committee in its 283<sup>rd</sup> meeting held during 2nd & 3<sup>rd</sup> march. 2015 considered the matter, reply from the institution dated 09.02.2015 to the show cause notice issued and all the relevant documentary evidence and decided to serve Show cause Notice under NCTE Act.

AND WHEREAS, in the meantime, on 09.02.2015 an affidavit from the Correspondent, Sri Andal Educational Cultual Society, Dwarakanagar,kothapet Hyderabad is received by this office expressing their willingness to process the application as per Regulations 2014.

AND WHEREAS, on 09.03.2015, the institution submitted its written representation based on the decision available from NCTE website.

AND WHEREAS, the SRC in its 285<sup>th</sup> meeting held on 17<sup>th</sup> April, 2015 considered the matter, reply of the Institution dated 09.03.2015 decided as under:-

### " Cause Inspection for shifting."

AND WHEREAS, the inspection of the institution was conducted on 23.04.2015 and the VT Report was received by this office on 27.04.2015.

AND WHEREAS, SRC in its 286<sup>th</sup> meeting held on 30<sup>th</sup> April, 2015 considered the matter and decided as under:-

" BCC is in the name of correspondent instead of the institution. Issue Show Cause Notice."

AND WHEREAS, on 05.05.2015, the institution has submitted a reply based on website information.

AND WHEREAS, in the meantime, as the institution had submitted affidavit expressing willingness towards adherence to Regulations, 2014, a revised provisional recognition order as issued to the institution on 26.05.2015.

AND WHEREAS, on 08.07.2015, a court order in W.P.MP.No. 23345 of 2014 in W.P.No. 37094 of 2014 is received by this office on 06.07.2015.

4ND WHEREAS, the Regional Committee in its 290<sup>th</sup> meeting held on 10<sup>th</sup> & 11<sup>th</sup> July, 2015, pairs dered the matter show bause notice reply from the institution vide their letter dated 15 17 2015, and other related accuments of the institution, decided as under:

- "1. This is a case of shifting from one block to another.
- 2. Permit shifting.
- 3. Ask them to submit latest approved faculty list for verification."

NOW THEREFORE, permission is hereby accorded by SRC to Gandhian College of Education, No.5-67, Umberper Road, Kuntloor, Hayat Nagar, Ranga Reddy District-500035, Andhra Pradesh to shift its premises to the new location / building at Gandhian College of Education, 3-58, Kuntloor Village, Hayat Nagar Mandal, Ranga Reddy District, Andhra Pradesh.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
