ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Shree Jagadguru Tontadarya Vidyapeeth, Gadag-582101, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Hardekar Manjappa D.Ed College, Alamatti Dam Site, Basawanabagewadi TaJuk, Bijapur-586201, Karnataka for Elementary(D.Ed) course of two years duration with an annual intake of 50 (Fifty) Students.

- 2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to Hardekar Manjappa D.Ed College, Alamatti Dam Site, Basawanabagewadi Taluk, Bijapur-586201, Karnataka for conducting Elementary(D.Ed) course of two years duration with an annual intake of 50(Fifty) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - i) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
 - ii) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - iii) The institution shall shift to its own premises / building within three years from the date of recognition. (in case the course is started in rented premises)

- iv) The institution will ensure that Principal and Five faculty members duly approved by DSERT, Bangalore are in position for an intake of 50" students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
- Further, the recognition is subject to fulfillment of all such other requirements as 4. may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
- The institution shall maintain & update the Web-site as per provisions of NCTE 6. Regulations.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.

Sub: Review of recognition granted by SRC, NCTE Mased on the complaint made by State Government of Karnataka against some institutions – reg.

Ref: APS06013

With reference to the above, Hardekar Manjappa D.Ed College, Alanatti Dam Site, Basavana Bagewadi Taluk, Bijapur-586201, Karnataka was granted recognition for offering D.Ed course vide order dated 26.09.2007 with an intake of 50 stutents.

A letter dated No.ED 122 PTI 2008 (B) dated 18.06.2009 was received from the Principal Secretary, Primary and Higher Education, Education Department, Government of Karnataka and has recommended SRC to withdraw the recognition granted to your D.Ed college as the institution is not maintaining norms and standards as prescribed by NCTE.

The matter was placed before SRC in its 178th meeting held on 13-14July 2009 and SRC considered the recommendation of the State Government of karnataka and decided to issue showcause notice. Accordingly, Notice was issued to the institution on 12.08.2009. The institution has submitted written representation on 1009.2009. The SRC in its 183rd meeting held on 22nd September 2009 considered the written representation and decided to issue notice. Accordingly, Notice was issued to the institution on 31.11.2009. The institution has not submitted any written representation to the notice, the matter was placed before SRC in its 189th meeting iteld on 25-26 February 2010 and SRC decided to issue final notice. Accordingly, Final notice was issued to the institution on 12.04.2010.

The institution submitted its written representation on 03.05.2010. The SIC in its 192nd meeting held on 10-11 May 2010 considered the written representation and decided to cause inspection. Accordingly, inspection was carried out on 04.06.2011. The matter was considered in its 193rd meeting held on 21-22 June, 2010 and it was decided to cause inspection and it was also decided payment Rs.40,000/- towards reinspection by the management. Accordingly, inspection was conducted on 14.07.2010.

As the institution has not submitted Rs.40,000/- towards re-inspection fee as decided in 193rd meeting held on 21-22 June 2010 a letter seeking for re-inspection fee was issued to the institution on 06.12.2010.

As the institution has not submitted re-inspection fee of Rs.41,000/- and a letter for continuation of recognition could not be issued. SRC in its 2015 meeting held on 22-23 February 2011 considered the matter and decided that a Reminder notice be issued for payment of Rs.40,000/- within a period of four weeks, failing which action will be taken with no further notice. Accordingly, a Reminder letter was issued to the institution on 09.03.2011. The institution submitted Rs.40,000/- vide Temand Draft bearing No.281588 dt.02.04.2011.

As per the decision of SRC, the recognition accorded to the institution by SRC-NCTE is continued.

The institution shall maintain norms and standards as prescibed by NCTE for the course from time to time.
