Preamble:

Indira Teacher Training Institute, Pandur, Thiruvallur District, Pin – 631293, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed. (Additional intake) Course.

Hon'ble High Court of Madras in W.P.37431, 39046 and 32248 of 2004 has directed NCTE to cause inspection within a period of 3 months. Accordingly, an inspection was carried out on 28.11.2005. The inspection report was placed before 105th SRC meeting held during 2-3 December 2005.

After considering the application and other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 13.12.2005 to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

The said institution was considered by the Regional Committee in its 106th meeting held on 15-16 December 2005 and decided to reject the proposal.

In terms of Section 14(1) of the NCTE Act, 1993 Indira Teacher Training Institute, Pandur, Thiruvallur District, Pin – 631293, Tamilnadu had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed. (Additional intake) Course of two year duration.

And whereas the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 13.12.2005 to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

And whereas the applicant institution as well as the other documents and materials submitted were duly considered by the Regional Committee on 106th SRC meeting held on 15-16 December 2005 which came to the conclusion that the recognition to the said institution be refused for the following reasons:

 The request for extra intake was not made in prescribed format and manner and the request is not accepted.

Now therefore, it is hereby ordered that recognition to **Indira Teacher Training Institute, Pandur, Thiruvallur District, Pin – 631293, Tamilnadu** to D.T.Ed. (Additional intake) course be refused.

As per Section 18 of NCTE Act, 1993, there is provision to prefer an appeal against the above order of refusal. A copy of the format to prefer the appeal is enclosed along with this order.
