ORDER**

WHEREAS, Ahmed Memorial Educational Society, No.17-3-1/5, S.R.T. Colony, Yakutpura, Hyderabad, Telangana had submitted an application to the Southern Regional Committee of NCTE seeking permission to start **Islamia College of Elementary Education, No.17-3-1/5, S.R.T. Colony, Yakutpura, Hyderabad -500023, Telangana for Elementary (D.Ed) Course of two years duration from the academic session 2005-06.**

AND WHEREAS, the recognition was granted to the institution on **24.08.2005** with an intake of 50 students from the academic session 2005-06 with a condition that the institution shall shift both B.Ed and D.Ed courses to own premises /building within three years from the date of recognition of B.Ed college as the recognition for D.Ed is issued based on existence of B.Ed college and notification dated 01.01.2014 of NCTE. (in case the B.Ed/ D.Ed courses is started in rented premises).

AND WHEREAS, on 25.03.2015, a letter is received from the Director of School Education, Telangana, Hyderabad regarding grant of renewal of temporary provisional affiliation for the year 2014-15 in respect of certain private Diploma in elementary Teacher Education Institution including Islamia College of Elementary Education, No.17-3-1/5, S.R.T. Colony, Yakutpura, Hyderabad -500023, Telangana in Telangana State.

AND WHEREAS, the SRC in its 289th meeting held on 23rd June 2015, considered the matter, letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad, in respect of certain private Diploma In Elementary Teacher Education (43 colleges) not fulfilling the deficiencies and it has decided to issue show cause notice for the following Deficiencies:

- Having 2564 Sq.mts built up area instead of 3000Sq.mts.
- Submitted hard copy of 1+5 approved staff list.

AND WHEREAS, show cause notice was issued to the institution on 16.09.2015.

AND WHEREAS, the SRC in its 290th meeting held on 28.09.2015 considered the letter from the Director School Education Department, Telangana State and decided to:

- Issue show cause notice to the institution for withdrawal of recognition for non submission of fire certificate by the college.

AND WHEREAS, show cause notice was issued to the institution on 28.09.2015 for non submission of Fire certificate.

AND WHEREAS, the institution has submitted show cause notice reply on 26.10.2015 along with relevant documents.

AND WHEREAS, the SRC in its 294th meeting held on 14th-15th -16th November, 2015 considered the matter and it has decided as under:

1. Considered SCN reply.
2. Lease deed cannot be accepted.
3. Withdraw recognition for D.Ed w.e.f 2015-16.

AND WHEREAS, before issuance of withdrawal order, the institution has submitted its written representation along with relevant documents on 23.11.2015.

AND WHEREAS, the SRC in its 297th meeting held on 27th & 28th December 2015, considered the written representation dated 23.11.2015 from the institution and decided to permit shifting.

NOW THEREFORE, permission is hereby accorded to **Islamia College of Elementary Education, No.17-3-1/5, S.R.T. Colony, Yakutpura, Hyderabad -500023, Telangana** to shift its premises to new location/building at **Islamia College of Elementary Education Sy.No.103/15, Bandlaguda Khalsa, Bandlaguda Village & Revenue Division, Hyderabad – 500004, Telangana.**

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
