**ORDER**

**WHEREAS**, SRC-NCTE granted recognition for offering B.Ed course to Islamia College of Education, # 17-3, 1/5, SRT Colony, Yakuthpura, Hyderabad District, Talangana on 04.04.2003 with condition to shift to its own premises within three years from the date of recognition.

**AND WHEREAS**, a letter has been received from the Institution on 27.07.2009 along with inspection fee and documents and requesting for inspection of own building at Bandlaguda.

**AND WHEREAS**, inspection of the institution was fixed between 7<sup>th</sup> - 12<sup>th</sup> February 2011. The inspection intimation was sent to institution on 27.01.2011. The inspection of the institution was conducted on 09.02.2011 and the VT report received in the office of SRC on 14.02.2011, it was not placed before SRC.

**AND WHEREAS**, on 31.12.2014, letters were sent to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

**AND WHEREAS**, the institution has submitted affidavit for offering B.Ed course with an intake of 100 on 24.06.2015.

**AND WHEREAS**, revised order was issued to the institution on 29.06.2015 subject to decision of SRC on VT report pending with this office.

**AND WHEREAS**, the institution has submitted its written representation on 21.08.2015 along with some documents.

**AND WHEREAS**, the SRC in its 297<sup>th</sup> meeting held on 27<sup>th</sup> & 28<sup>th</sup> December 2015, considered the written representation dated 23.11.2015 from the institution and decided to permit shifting.

**NOW THEREFORE**, permission is hereby accorded to Islamia College of Education, # 17-3, 1/5, SRT Colony, Yakuthpura, Hyderabad District, Talangana to shift its premises to new location/building at Islamia College of Education Sy.No.103/15, Bandlaguda Khalsa, Bandlaguda Village & Revenue Division, Hyderabad – 500004, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
