ORDER

Whereas, J.S.J.V Teacher Training Institute, Cuddalore, Tamilnadu had submitted an application for grant of recognition to D.T.Ed course. Recognition to the institution was granted to the institution on 23.12.2006 for D.T.Ed course & D.T.Ed-Al on 06.11.2007 with annual intake of 100 students.

And whereas, as per decision of SRC in its 175th meeting of SRC held on 13-14th May 2009, the office of SRC has reviewed the files of the institution who have been granted recognition either in a rented premises pending construction of own building or in lease premises. A list of such institutions has been prepared and placed before SRC in its 181st meeting held on 20th-21st August 2009 wherein, it was decided that the institution which have not shifted to the permanent premises even after the expiry of three years time limit be issued notice under Section 17 of NCTE Act for further action. Accordingly a notice was issued to the institution on 16.09.2009.

And whereas, the institution has not submitted reply to the above notice so far. Instead the institution has submitted letter dated 12.04.2010 requesting for change of name from <u>J.S.J.V. Teacher Training Institute</u> to <u>C.K. Teacher Training Institute</u>. The matter was considered by SRC in its 191st meeting held on 20th-21st April 2010. The Committee considered the brief note about the College and also the complaints received against the institution and has decided to issue Final Notice to the institution As per the decision of SRC, final show notice was issued to the institution on 18.05.2010. The institution has submitted its reply on 01.06.2010.

And whereas, the Committee in its 193rd meeting held on 21st-22nd June 2010 considered the reply to the Notice and decided to withdraw recognition. Accordingly, withdrawal order was issued vide order No. F.SRO/NCTE/2010/20030, Dt. 27.07.2010. Recognition to D.T.Ed-Al was also withdrawn vide order No. F.SRO/NCTE2010/21089. Dt. 14.09.2010.

And whereas, aggrieved by the withdrawal order, the institution preferred appeal under Section 18. The Appellate Authority vide order dated 18.11.2010 & 23.12.2010 reversed the SRC order dated 27.07.2010 & 14.09.2010 with direction to SRC to examine the reply furnished by the institution and take appropriate decision thereafter. The committee in its 199th meeting held on 22nd-23rd December 2010 noted the Appellate authority order and decided to issue a show cause notice.

Accordingly showcause notice was issued to the institution on 11.02.2011. The institution submitted its reply on 01.03.2011. The Committee in its 202nd meeting held on 14th-15th March 2011 considered the reply of the institution dt. 01.03.2011 and all the relevant documentary evidences and it was decided to serve Show cause Notice under Section 17 of NCTE Act. Accordingly show cause notice was issued to the institution on 11.04.2011. The institution submitted its reply on 24.03.2011 which was prior to issue of notice dt.11.04.2011 after seeing the decision of SRC in SRC Website.

And whereas, the Committee in its 204th meeting held on 27th-28th April 2011 considered the VT report of the institution, VCD, reply of the institution dt. 27.04.2011 and other related documents along with the original file of the institution, and decided that shifting to new/permanent premises is permitted.

And whereas, it is observed while examining the Appellate Authority order that withdrawal of recognition by SRC on the ground of not shifting was not in order according to Appeal Committee. When this was not in order the decision of SRC to permit shifting new premises is to be re-considered.

And whereas, the committee in its 206th meeting held on 09th-10th June 2011 decided to reconfirm the earlier decision taken in its 204th meeting held on 27-28 April 2011 permitting shifting to new/permanent premises. (The recognition had already been restored by Appeal Committee reversal of the SRC's withdrawal order).

NOW, THEREFORE, the institution is permitted to shift to J.S.J.V. Teacher Training Institute, Jayaram Nagar, Chellangappam, Cuddalore District-607003, Tamilnadu for conducting D.T.Ed course with annual intake of 100 (which includes existing & additional intake).

Also order that a copy of this order be published in the Official Gazette.
