ORDER

WHEREAS, JES College of Education, Vishakapatnam Revenue Division, #30-06-2010, Perm Samagam Road, Daba Gardens, Vishakapatnam District – 530020, Andhra Pradesh SRC-NCTE granted recognition for B.Ed course to JES College of Education, Vishakapatnam Revenue Division, #30-06-2010, Perm Samagam Road, Daba Gardens, Vishakapatnam District – 530020, Andhra Pradesh on 08.04.2003.

AND WHEREAS, a letter was received from the institution on 22.10.2003 enclosing the staff list of the institution Performance appraisal report was received from the institution on 23.01.2004 for the academic year 2002-03. The institution has also submitted experience & academic certificates of the Principal on 13.02.2004 and 16.02.2004.

AND WHEREAS, a letter was received from the institution on 28.09.2006 with a request for permission to shift along with a demand draft of Rs. 40,000/- (D.D was taken into account vide receipt no. 11937 dated 19.01.2007).

AND WHEREAS, the SRC in its 178<sup>th</sup> meeting held during 13<sup>th</sup> to 144<sup>th</sup> July, 2009 observed from records of the list of institutions that the institution were accorded recognition in the rented premises and they had not yet shifted to the permanent premises/ building. In view of non-shifting of the colleges to permanent building. The Committee decided to issue Show Cause Notice under Section 17 of the NCTE Act and obtain shifting fees and other documents for causing inspection for shifting.

AND WHEREAS, as per the decision of SRC, a show cause notice was issued to the institution on 01.09.2009 for the following deficiencies :-

1. Demand draft of Rs, 10,000/- towards inspection fee in favour of the 'The Member Secretary, NCTE' payable at Bangalore should be submitted.
2. Land documents of the new building /location for having own land in the name of the institution /Society/Trust.
3. Building plan of the new building duly approved by the Government authority
4. Building Completion certificate from the Government authorities in the prescribed format ( format enclosed)
5. Land usage certificate from the concerned Government authorities stating that the land is exclusively permitted/sanctioned for Educational Purpose only should be submitted.
6. Encumbrance certificate from the competent Government authority should be submitted.
7. Fixed deposit of Rs. 5 lakhs kept in joint account with SRC in Nationalized Bank for a period of 5 years towards endowment fund in original should be submitted.
8. Fixed deposit of Rs. 3 lakhs kept in joint account with SRC in Nationalized Bank for a period of 5 years towards endowment fund in original should be submitted.
9. Certificate of Registration/Bye-Law of the Society/Trust should be submitted.

10. The affidavit in Rs. 100/- stamp paper in the prescribed format with Notary attested should be submitted( format enclosed)

**AND WHEREAS**, the SRC in its 201<sup>st</sup> Meeting held on 22<sup>nd</sup> – 23<sup>rd</sup> February, 2011 considered the non-submission of show cause notice reply and the Committee has decided to withdraw the recognition.

**AND WHEREAS**, as per the decision of SRC, a withdrawal order was issued to the institution on 07.04.2011.

**AND WHEREAS**, the institution had submitted a letter dated 03.10.2013 received in this office of SRC on 14.10.2013 requesting to cause inspection at an early date.

**AND WHEREAS**, the Hon'ble High court order dated 24.04.2015 in W.P.No. 12341 of 2015 is order as follows:

"..... I deem it appropriate to dispose of the writ petition itself with a direction to the respondent to consider and dispose of the representations dated 15.4.2014 and 10.3.2015 said to have been submitted by the petitioner, by passing appropriate orders within two weeks from the date of receipt of copy of this order, as per law".

*Accordingly, Writ Petition is disposed of at the admission stage. Miscellaneous petitions pending, if any, shall stand closed.*

**AND WHEREAS**, the SRC in its 286<sup>th</sup> meeting held during 30.4.2015 has considered the above court matter and decided to obtain relevant documents for shifting of premises and change of management.

**AND WHEREAS**, based on the website information, the institution on 18.5.2015 has submitted the following documents.

**AND WHEREAS**, the Southern Regional Committee in its 287<sup>th</sup> meeting held during 20<sup>th</sup> May, 2015 considered the matter, court order directions and other relevant documents of the institution and decided to cause inspection for shifting.

**AND WHEREAS**, the inspection of the institution was conducted on 14.06.2015 and the VT report was received by this office on 18.06.2015.

**AND WHEREAS**, the Committee Regional Committee in its 290<sup>th</sup> meeting held on 10<sup>th</sup>-11<sup>th</sup> July, 2015, considered the VT report and decided to restore recognition and shifting permitted.

**NOW THEREFORE**, recognition accorded to **JES College of Education, Vishakapatnam Revenue Division, #30-06-2010, Perm Samagam Road, Daba Gardens, Vishakapatnam District -530020, Andhra Pradesh** for B.Ed course is hereby restored/continued till further orders and permitted to shift its premises to the new location / building at **JES College of Education, Plot No. 14-163, Chinna Mushdivada, Pendurthy Mandal, Visakhapatnam District, Andhra Pradesh.**
