## ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Jay Bharath Pre-primary Teacher Training Institute, New Government Polytechnic, Attingal, Avanavancherry – 695103, Kerala had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting Pre-primary course of one year duration from the academic session 2003-2004 with an annual intake of 40 students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - a) The institution has acquired the land for setting up the teacher education institution.
  - b) The institution has made arrangements for conducting the course in temporary premises.
  - c) The institution has created Endowment Fund of Rs.5,00,000/- and a Reserve Fund of Rs.1,00,000/-
  - d) The institution has selected the Principal and **Four** teachers for the said course and the staff list is approved by SCERT, Kerala.
- Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Jay Bharath Pre-primary Teacher Training Institute, New Government Polytechnic, Attingal, Avanavancherry 695103, Kerala for Pre-primary course of one year duration from the academic session 2003-2004 with an annual intake of 40 subject to fulfillment of the following.
  - a) The institution will ensure that **five** faculty members are in position for an intake of **40** students before commencement of the course and a report to this effect shall be sent to the Committee immediately and in any case not later than one month from the date of commencement of the course.
  - b) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).
  - c) The infrastructure and instructional facilities are made adequate to conduct various activities as suggested in the norms.
  - d) Books and journals be added to the library to fulfil NCTE norms.
  - e) Endowment and Reserve Fund shall be deposited as per State norms.
  - f) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.

- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like State Government etc.,
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body for the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. The certificate given by the State of Kerala will be valid for employment within Kerala only and that the duration and admission criteria are those that exist in the State of Kerala prior to the promulgation of the NCTE Act. The institution is permitted to conduct the course of one year duration upto 2004-2005 only. Thereafter the course has to be switched over to two years as per NCTE norms.
- 7. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
