Preamble:-

AND WHEREAS, recognition order was issued vide order F.No.SRCAPP883/D.El.Ed/AP/2013-14/52382 dated 20.6.2013 for D.Ed course with an intake of 50 students from the academic session 2014-15 as per Supreme Court Order dated 13.12.2012 filed by Maa Vaishno Devi Mahila Maha Vidyalaya.
