<p>WHEREAS, St. Augustine's Educational Society, H.N. 2-5-79, Near old bus stand, Sircilla, Karimnagar, Telangana had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Jyothi College of Elementary Education, Thangallapally, Sircilla, Karimnagar District, Andhra Pradesh for Elementary (D.Ed) course of two year duration from the academic session 2005-2006 with an annual intake of 50 students. The institution was granted recognition for D.Ed course on 05.08.2005.</p>	<p>WHEREAS, St. Augustine's Educational Society, H.N. 2-5-79, Near old bus stand, Sircilla, Karimnagar, Telangana had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Jyothi College of Education, Karimnagar District, Andhra Pradesh for Secondary (B.Ed) course of one year duration from the academic session 2002-2003 with an annual intake of 100 students. The institution was granted recognition for B.Ed course on 03.03.2003.</p> <p>AND WHEREAS, the institution has submitted original affidavit for offering B.Ed course with an intake of 100 students on 18.03.2015.</p> <p>AND WHEREAS, the SRC in its 276th meeting held on 7th -9th January, 2015 decided to issue provisional recognition orders to the existing institutions as and when the affidavits are received by this office.</p> <p>AND WHEREAS, revised order was issued to the institution on 12.05.2015 with the FDR condition.</p>

AND WHEREAS, the institution has submitted proposal for change of management on 07.08.2015 & 28.11.2015 along with some relevant documents.

AND WHEREAS, the SRC in its 297th meeting held on 25th - 27th February, 2016 considered the matter and request for change of management and it has decided as under:

1. NOC from University is there.
2. NOC from SCERT is not there. Ask them to produce SCERT's NOC.
3. All other requirements are fulfilled.
4. No fee is prescribed for dealing with such applications. Therefore, refund the amount received.

AND WHEREAS, the institution has submitted its written representation along with NOC from SCERT on 18.02.2016.

AND WHEREAS, the SRC in its 304th meeting held on 19th & 20th February, 2016 considered the matter and it has decided to:

- All formalities have been completed, therefore change of management as requested is permitted.

AND WHEREAS, the order was issued to the institution on 25.03.2016

AND WHEREAS, an e-mail received by the institution on 17.11.2015 regarding shifting premises.

AND WHEREAS, the SRC in its 304th meeting held on 19th & 20th February, 2016 considered the matter and decided to "**Cause inspection for shifting**".

AND WHEREAS, inspection intimation was sent to the institution and VT members on 16.03.2016. The Inspection of the institution was conducted on 24.03.2016 and VT report along with documents received on 28.03.2016.

AND WHEREAS, the SRC in its 308th meeting held on 28th – 30th March, 2016 considered the VT report and it has decided as "**shifting permitted**".


NOW THEREFORE, permission is hereby accorded to **Jyothi College of Education (APS00280) & Jyothi College of Elementary Education (APS02604), Thangallapally, Sircilla, Karimnagar District, Andhra Pradesh** to shift its premises to new location/building **Jyothi College of Education (APS00280) & Jyothi College of Elementary Education (APS02604), H.No. 3-115/1, Thadoor Village, Sircilla Mandal, Karimnagar District – 505405, Telangana.**

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
