In Para-3	AND WHEREAS, on scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 29.09.2010.	AND WHEREAS, the SRC has decided to permit the institution to have <b>100</b> intake with <b>two basic units</b> of 50 students each.
In Para-4	AND WHEREAS, the SRC has decided to permit the institution to have <b>two basic units</b> of 50 students each subject to the institution fulfilling following conditions namely,  I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31 <sup>st</sup> July, 2015 failing which recognition will be withdrawn.  ii. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution does not fulfill required norms of infrastructure recognition will be withdrawn.  III. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.  IV. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

	V. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
