ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to **Krishna Teacher Training Institute, Panangad, Thrissur - 680665, Kerala**, for **Elementary course** of one year duration from the academic session **2001-2002** with an annual intake of **33**, subject to fulfilling the following conditions:

1. The institution shall function with one Principal and five full time teaching staff qualified as per NCTE norms.
2. Librarian, Assistant Librarian and Technical Assistant should be appointed as per NCTE norms.
3. Physical Education teacher and Instructors for Work Experience, Art & Music and Education Technology should be appointed as per NCTE norms.
4. Education Technology lab should be equipped as per NCTE norms.
5. 500 more books should be added to the library and 3 educational journals should be subscribed to as per NCTE norms.
6. Accommodation for Education Technology lab and Common room should be provided.
7. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the norms before commencement of the academic session 2002-2003.
8. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
9. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating University / State Government as the case may be.
10. Tuition fee and other fees will be charged from the students as per the norms of the affiliating University / State Government as the case may be till such time NCTE regulations in respect of fee structure come into force.

11. Curriculum management including content, work load and the staff to implement the norms and standards for the course and the requirements of the syllabus, including evaluation, etc. as the case may be.
12. Teaching staff including practice teaching should not be less than the notified in the NCTE norms for the course.
13. The institution should have a teacher recruitment and reservation as per NCTE norms.
14. The institution should continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Annual Report and the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If **Krishna Teacher Training Institute, Panangad, Thrissur - 680665, Kerala**, contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
