ORDER**

WHEREAS, Grace Educational Society, Ramanthapur, Hyderabad District, Telangana has applied for grant of recognition to **Karunodaya D.Ed College, H.No.1.129/1-A, Hydershah Kote(V), Rajendra Nagar (M), Ranga Reddy District – 500008, Telangana** for offering D.Ed course of **two years** with an intake of **50 students**.

AND WHEREAS, the recognition was granted to the institution on 26.08.2005 with an intake of 50 students from the academic session **2005-06.**

AND WHEREAS, the institution has submitted its written representation on 22.09.2015 along with relevant documents and D.D. of Rs.1,50,000/- bearing no.734228 dated 19.09.2015 and 28.10.2015 regarding shifting premises.

AND WHEREAS, the SRC in its 293rd meeting held on 29th to 31st October, 2015 considered the matter and decided as under:

1. **Process the case for causing shifting inspection.**
2. **In the meantime request the Affiliating body to renew affiliation.**

AND WHEREAS, letter was sent to the Director SCERT on 29.01.2016.

AND WHEREAS, the SRC in its 305th meeting held on 25th to 27th February, 2016 considered the matter and decided to **“Cause Inspection for shifting and Inform SCERT for admissions.”**

AND WHEREAS, the information letter was sent to the Director, SCERT on 25.03.2016.

AND WHEREAS, inspection intimation was sent to the institution and VT members on 17.03.2016. The Inspection of the institution was conducted on 25.03.2016 and VT report along with documents received on 28.03.2016.

AND WHEREAS, the SRC in its 308th meeting held on 28th – 30th March, 2016 considered the VT report and it has decided to **“Permit shifting.”**


NOW THEREFORE, permission is hereby accorded to **Karunodaya D.Ed College, H.No.1.129/1-A, Hydershah Kote(V), Rajendra Nagar (M), Ranga Reddy District – 500008, Telangana** to shift its premises to new location/building at **Karunodaya D.Ed College, Parigi, Rangareddi District – 501501, Telangana.**

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
