ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Lakshmi Ammal Teacher Training Institute, Sirunathur Village, Tindivanam Road, Tiruvannamalai District – 604601, Tamilnadu had submitted application to the Southern Regional Committee of NCTE for grant of recognition for D.T.Ed Course on 01.01.2006

AND WHEREAS, the Southern Regional Committee, after considering the report of the visiting team as well as other relevant materials granted recognition to the institution for D.T.Ed course on 13.11.2006 with an annual intake of 50 students with stipulation that the institution shall shift to its own premises/building within three years from the date of recognition.

AND WHEREAS, the institution vide its letter dated 27.10.2010 submitted Rs.40,000/- for shifting of premises. Accordingly, the inspection of the institution was fixed between 18-23 April 2011. The same was intimated to the institution on 11.04.2011. Accordingly, inspection of the institution was conducted on 05.05.2011.

AND WHEREAS, the management is also running B.Ed course in the same building/premises.


AND WHEREAS, the SRC in its 206th meeting held on 9-10 June 2010 considered the VT Report, VCD and all the relevant documentary evidences and decided to serve Show cause Notice to all the courses, under Section 17 of NCTE Act. Accordingly, a Show cause notice was issued to institution on 04.07.2011. The institution had submitted its written representation on 01.08.2011.

AND WHEREAS, the SRC in its 213th meeting held on 6- 7 November, 2011 considered the reply of the institution, VT Report, and all relevant records of the institution and decided that, since all the requirement have been satisfactorily fulfilled, shifting may be permitted.

NOW THEREFORE, permission is hereby accorded by SRC to Lakshmi Ammal Teacher Training Institute, Sirunathur Village, Tindivanam Road, Tiruvannamalai District – 604601, Tamilnadu to shift its premises to the new location / building at Lakshmi Ammal Teacher Training Institute, Sirunathur – 606601, Thiruvannamalai Taluk & District, Tamilnadu.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
