ORDER

WHEREAS, Elite Educational Society, East Godavari District, Andhra Pradesh had applied for grant of recognition to Little Rose College of Elementary Education, Draksharama Mandal , East Godavari District -533262, Andhra Pradesh, for D.Ed course of two year duration under section 14(1) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE on 27.12.2005.

AND WHEREAS, the application was processed and the inspection of the institution was carried out on 03.04.2007. SRC in its 141st Meeting held on 6th - 9th September, 2007 the SRC after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfil the requirements and issued a notice on 02.01.2008 to the applicant institution under provision to section 14(3) (b) of the NCTE Act, 1993, thereby giving an apportunity to the said applicant institution to make a written representation for the following:

- The building is under construction
- 2. The labs and library is not established
- 3. Furniture is not adequate

AND WHEREAS, the institution submitted its reply on 12.02.2008 which was placed in the 154th Meeting held on 21st -22nd February, 2008, the SRC after considering the relevant materials furnished by the applicant institution, which came to the conclusion that recognition to the said institution for D.Ed course be refused for the following reasons:

- Building completion certificate is not submitted.
- The building is under construction
 The labs and library is not established
- 4. Furniture is not adequate

AND WHEREAS, Accordingly, a refusal order was issued to the institution on 14.03.2008, Aggrieved by the refusal order of SRC, the institution preferred an appeal to NCTE-Hors and the appellate authority reversed the order appealed against vide its order dated 18.08.2008, and instructed to cause re-inspection of the institution. Meanwhile a letter dated 07.01.2009 forwarded by Principal Secretary of Education was received requesting not to accord further recognition/permission to the new colleges/private B.Ed. D.Ed. Physical Education, Language Pandit in the state of Andhra Pradesh as the above Colleges are exceeding in numbers than required. The matter was placed before SRC in its 173rd meeting held on 20th -23rd April. 2009 which came to the conclusion to close the application of the institution.

AND WHEREAS, therefore application of Little Rose College of Elementary Education, Draksharama, East Godavari - 533262, Andhra Pradesh for D.Ed course in terms of section 14(3)(B.Ed) of the NCTE Act, 1993. was closed on 05.05.2009.

The institution ignored to approach Appellate Authority, NCTE Head Quarters and directly approached Hon'ble High Court in Writ Petition no 2112 of 2011 wherein the Hon'ble High court passed an order as under

"In that view of the matter, having regard to the fact that the application of the first petitioner society is also prior to the present policy notified by the Government and the respondents considered such application applying the present policy of the Government, order bearing No.F.SRO/NCTE/2008-09/12360, dated 05.05.2009, rejecting the request of the first petitioner society to run, D.Ed College, is set aside and the respondents are directed to reconsider the application of the first petitioner society with reference to the policy, which was in force, during relevant year, when the application was initially submitted by it, and take steps accordingly, for grant of permission as prayed for.

AND WHEREAS, the Court order was placed in 202nd Meeting of SRC held on 14th-15th March, 2011, and It was decided to direct the institution to submit all relevant documents including the latest building completion certificate from a Govt. Engineer, evidence of Endowment and Reserve Fund deposits and others, for consideration, as per Court orders for further processing. Accordingly a letter was sent to the institution on 19.04.2011. The institution has submitted its original file along with FDR's on 26.04.2011.

AND WHEREAS, the SRC in its 206th Meeting of SRC held on 9th – 10th June, 2010 considered the Hon'ble High Court orders, written reply of the institution dt. 26.04.2011 and all the relevant documents by the institution and decided to cause inspection at the premises. Accordingly inspection of the institution was conducted on 27.07.2011 & VT Report was received in the SRC-NCTE on 29.07.2011.

AND WHEREAS, in SRC's 201st meeting held on 22rd-23rd February, 2011 recognition of B.Ed course (APS00227) run by Little Rose College of Education, Rajamundry Revenue Division, Draksharama, East Godavari District - 533 262, AP, vide letter dt. 9.11.2011, for the reasons that they failed to shift to permanent premises within the prescribed time limit of three years as per the norms, and also they had failed to respond to Show cause notices issued by SRC.NCTE long back on 07.10.2009.

AND WHEREAS, the management went for an appeal and as per Appellate authorities order dt. 03.05.2011 considered the matter and decided to cause shifting inspection at the premises under section 17 of NCTE Act. The institution is directed to submit inspection fee of Rs. 40,000/-.vide letter dt. 09/11/2011.

AND WHEREAS, the SRC decided that, in conformity with the High Court order, the case is reconsidered with respect to the pre-2009 Regulations. Since all conditions have been fulfilled, the committee decided to grant Letter of Intent to this institution.

On careful perusal of the original file of the institution, court order dt. 13.07.2010 and other related documents, Act of NCTE, 1993, Regulations and guidelines of NCTE published from time to time laid on the table, the Regional Committee decided to issue <u>Letter of Intent</u> for grant of recognition to D.Ed course (APS04730) of two year duration with an annual intake of 50(Fifty only)(one unit) for the academic year 2012-13 subject to the appointment of qualified staff through duly constituted selection committee as per the Norms of NCTE/State Government/Affiliating body and be given effect before the commencement of the academic session.

AND WHEREAS, As per direction of Southern Regional Committee in its meeting 213th letter of intent prior to recognition was issued to applicant institution on 29,11.2011. In response to this office letter dated 29,11.2011 the institution has submitted reply vide letter dated 02.07.2012. The list of staff is signed as possessing qualification by Director SCERT, Hyderabad, Andhra Pradesh. As per possessing observed by the Director, SCERT, Hyderabad Andhra Pradesh

AND WHEREAS. On Careful perusal of the original file of the institution and staff profiles submitted by the institution in response to the letter of Intent, the Regional Committee decided that Formal Recognition be granted to D.Ed., course of two year duration with an annual intake of 50 (Fifty only) students.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to Little Rose College of Elementary Education, Draksharama Mandal, East Godavari District - 533262, Andhra Pradesh for conducting D.Ed Course of two year duration with an annual intake of 50 (Fifty only) students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

 The endowment fund of Rs.5 takhs and reserve fund of Rs.3 takhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.

II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
