PREAMBLE :

Read: Notification of NCTE, New Delhi dated.01.01.2004 published in the Gazette of India Part III – Section 4 as No.3 on 05.01.2004

The NCTE, New Delhi in its Notification dated.01.01.2004 decided to dispense with the requirement of "No Objection Certificate" from State/UT Government for those institutions already running B.Ed programmes recognised by NCTE and seeking recognition to start a course or training in Elementary Teacher Education for a period of three years from the date of notification of these regulations in the Official Gazette.

The Sri Venkateshwara Educational Society, Suryapet-508213, Nalagonda District, Andhra Pradesh is running M.S.R. College of Education, Suryapet, Nalagonda District, Andhra Pradesh which has been granted recognition by SRC-NCTE has submitted an application to start Elementary (D.Ed) course by deriving the benefit of above said regulation on 03.02.2004.

The application for starting M.S.R. Institute of Elementary Teacher Education, 1-6-141/19, Bye-pass Road, Suryapet-508213, Nalagonda District, Andhra Pradesh was considered by SRC-NCTE under Section 15 of NCTE Act, 1993. Accordingly, inspection of the institution was carried out on 17.03.2005 and the report of inspection team and other documents furnished by the institution along with the application were considered by the Southern Regional Committee in its meeting held on 19-20 July, 2005. The Regional Committee observed that the institution has made satisfactory arrangements in respect of infrastructural and instructional facilities for starting D.Ed course and decided to permit the institution to start Elementary (D.Ed) course from the session 2005-06.

Hence the order.

ORDER

In terms of Section 15(1) of the NCTE Act, 1993, the Sri Venkateshwara Educational Society, Suryapet-508213, Nalagonda District, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE seeking permission to start M.S.R. Institute of Elementary Teacher Education, 1-6-141/19, Bye-pass Road, Suryapet-508213, Nalagonda District, Andhra Pradesh for Elementary(D.Ed) Course of two years duration from the academic session 2005-06 with an annual intake of 50 students.

6. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

7. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

8. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc ;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.
