- 2. AND WHEREAS, the institution ,Mahatma Gandhi College of Teacher Education, Vaikom Road, Tripunithura, Ernakulam - 682301, Kerala has by affidavit consented to come under New Regulations and sought for one basic unit in B.Ed.
- AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 3. students subject to the institution fulfilling following conditions namely
 - The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31st July, 2015 failing which recognition will be withdrawn.
 - 11. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn.
