ORDER

WHEREAS, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

- 2. ,Mahatma Gandhi University College of Teacher AND WHEREAS, the institution Education, Thottakad, Kottayam District, Kerala has by affidavit consented to come under New Regulations and sought for one basic unit in B.Ed.
- AND WHEREAS, on scrutiny it is found that recognition of the University Centre was withdrawn on 23.02.2010. The institution has filed a W.P. No. 20984 of 2010 in the Hon'ble Court and the Hon'ble Court vide order dated 07.07.2010 has granted an interim stay on the withdrawal order of SRC and the appellate authority order dated 05.05.2010. The revised order is issued subject to the result of the W.P.(C). No. 20894 of 2010 and the decision of SRC, NCTE on the result of the W.P.(C). No. 20894 of 2010
- 4. AND WHEREAS, it has been decided to permit the institution to have one basic unit of 50 students
- NOW THEREFORE, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Mahatma Gandhi University College of Teacher Education, Thottakad, Kottayam District; Kerala for conducting B.Ed programme of two years duration with an annual intake of 50 students(one basic unit) from the academic session 2015-16.
- Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.
- 7. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 8. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h). Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
