ORDER**

WHEREAS, Mallareddy Educational Society, Hyderabad, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Malla Reddy College of Education, H.No.1-238, Madhavanagar, Miyapur, Hyderabad -500049, Andhra Pradesh for Secondary (B.Ed) course of one year duration with an annual intake of 100 Students on 02.08.2007.

AND WHEREAS, on 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations 2014, seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, the institution submitted the affidavit for offering B.Ed course with an intake of 100 students (2 units of 50 each) on 30.01.2015.

AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 decided to issue provisional recognition orders to the existing institutions.

AND WHEREAS, on 13.04.2015, a letter dated 08.04.2015 was received from Malla Reddy College of Education D/No. 1-238, Madhavanagar, Miyapur, Hyderabad along with shifting fee of Rs. 50,000/- regarding Shifting of the College from leased building to own building.

AND WHEREAS, revised recognition order was issued to the institution on 06.05.2015 with a condition that the institution has not maintained revalidated FDR's. The institution submitted FDRs of Rs. 5 lakhs and 7 lakhs on 30.06.2015.

AND WHEREAS, the SRC in its 289th meeting held on 23.June, 2015 considered the institution written representation and decided as under:

1. **Affidavit received.**
2. **Collect the balance of Rs. One lakh towards inspection.**
3. **Ask VT to collect all missing documents (Viz, BCC, LUC and approved staff list as per 2014 Regulations).**

AND WHEREAS, information letter was sent to the institution on 22.07.2015.

AND WHEREAS, the institution has submitted written representation on 30.06.2015 along with the fee of Rs. 1,00,000/- bearing DD No.500188 dated 26.06.2015.

AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May, 2016 considered the matter decided as under:

1. **This is case of shifting B.Ed (2 units)**
2. **BCC is not by competent authority.**
3. **Ask VT to collect all relevant documents.**
4. **Cause shifting inspection.**

AND WHEREAS, as per the decision of SRC inspection intimation was sent on 03.08.2016. Inspection of the institution was conducted on 21.08.2016 and VT report along with documents and CD received on 27.08.2016.

AND WHEREAS, the SRC in its 321st meeting held on 28th - 30th September, 2016 considered the VT report and decided to issue show cause notice for the following:

1. **Land area is inadequate.**
2. **BCC not approved by competent authority.**
3. **Original FDRs not given.**
4. **Latest faculty list - not given**
5. **Issue SCN accordingly.**

AND WHEREAS, before issuance of show cause notice, institution submitted its reply along with documents on 27.10.2016.

AND WHEREAS, the SRC in its 326th meeting held on 04th & 05th January, 2017 considered the show cause notice reply and decided as under:

1. Faculty list is checked. It is in order.
2. Permit shifting.

AND WHEREAS, as per decision of SRC shifting order was sent on 13.01.2017.

AND WHEREAS, the institution submitted its written representation on 27.01.2017 request that the shifting order issued to the college does not specify the academic year.

AND WHEREAS, the written representation placed before SRC in its 333rd meeting held on 24th March, 2017 and the Committee considered the matter and decided as under:


1. Issue a revised shifting order showing the effective academic year as 2017-18.
2. Inform the affiliating University.

NOW THEREFORE, permission is hereby granted to **Malla Reddy College of Education, H.No. 1-238, Madhavanagar, Miyapur, Hyderabad -500049, Andhra Pradesh** for shifting of premises from **Malla Reddy College of Education, H.No. 1-238, Madhavanagar, Miyapur, Hyderabad -500049, Andhra Pradesh** to **Malla Reddy College of Education (B.Ed), Plot No. 38, Jayabheri Park Road, Kompally Village, Quthubullapur Mandal, Ranga Reddy District – 500014, Telangana** w.e.f the academic year 2017-2018.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this Order be published in the Official Gazette.

NOTE: In view of the decision of SRC in its 326th meeting the Shifting Order issued vide F.SRO/NCTE/APS07146/B.Ed/TS/2016-17/91064 dated: 13.01.2017 is cancelled.
