**ORDER**

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Mercy Teacher Training Mercy Teacher Training Institute, No.164, Periya Vanniya Street, Opp.Gandhi Park, Chidambaram, Cuddalore District, Tamilnadu had submitted an application for D.T.Ed Course on 02.01.2006. The institution was granted recognition on 26.10.2006 with an annual intake of 50 students, with the condition to shift to own premises within 3 years.

AND WHEREAS, the institution vide letter dt Nil received on 03.02.2010 has submitted proposal for shifting of premises. Further, the institution has submitted Demand Draft bearing no. 434585 dated 28.01.2010 for Rs. 40,000/- as shifting fee.

AND WHEREAS, in the meanwhile, the Directorate of Teacher Education, Research and Training, Chennai-600006 forwarded a copy of inspection report of the institution which was considered by SRC in its 202<sup>nd</sup> meeting held on 14<sup>th</sup>-15<sup>th</sup> March 2011 and decided to issue show cause notice. Accordingly, a notice was issued to the institution on 18.04.2011. The institution had submitted its reply on 13.05.2011.

AND WHEREAS the SRC in its 205<sup>th</sup> meeting held on 16<sup>th</sup>-19<sup>th</sup> May 2011 considered the reply of the institution dt.13.05.2011, VT report and decided to cause inspection of the institution under section 17 of NCTE Act. Accordingly, shifting inspection of the institution was conducted on 29.07.2011

AND WHEREAS, the SRC in its 213<sup>th</sup> meeting held on 06<sup>th</sup>-07<sup>th</sup> November, 2011 considered the VT Report, and all the relevant documentary evidences and decided to serve Show cause Notice under section 17 of NCTE Act. Accordingly, a Show cause notice was issued to the institution on 21.12.2011. The institution had submitted its written representation on 10.01.2012.

AND WHEREAS, the SRC in its 217<sup>th</sup> meeting held on 08<sup>th</sup>-09<sup>th</sup> February, 2012 considered the reply of the institution vide letter dt. 10.01.2012, VT report of the institution, VCD and other related documents, along with the original file institution and decided to continue recognition accorded to the institution. Accordingly, letter for continuing recognition was issued to the institution on 09.04.2012.

AND WHEREAS, now, the institution vide its letter dt. 04.04.2013 requested for issue of shifting order to the following address.
