ORDER

WHEREAS, Mother Mary Educational Society, Kisan Nagar, Bhongir, Nalgonda District, Telangana has applied for grant of recognition to Mother Mary Elementary Teacher Training Institute, Plot No.101, Chintal, Narketpally, Nalgond District – 508116, Telangana for offering D.Ed course of two years with an intake of 50 students.

AND WHEREAS, the recognition was granted to the institution on 26.08.2005 with an intake of 50 students from the academic session 2005-06.

AND WHEREAS, a letter has been receive from Govt. of Andhra Pradesh, School Education (PE) Department Vide letter G.O. Rt.No.521 dated 01.07.2011. As per perusal of the above letter certain Private D.Ed colleges of Andhra Pradesh had submitted representation to the Hon'ble Minister stating that they have admitted extra students in D.Ed 1<sup>st</sup> year after completion of 3<sup>rd</sup> phase DIET-CET-2010 counseling during the academic year 2010-2011. However, during the 4<sup>th</sup> phase counseling, the convener DIET-CET-2010 have allotted students to the vacant seats of their college under category-A seats and requested to the Government to accord permission for the extra seats for the year 2010-2011 as a special case.

AND WHEREAS, after examination of the matter by the State Government keeping in mind that the students who were admitted in excess by the institutions are at no fault, the Government ratified the action of the Managements of (28) private D.Ed colleges in filling of excess seats for the academic year 2010-2011, as a special case, with a strict warning to the managements of such institutions not to repeat such unauthorized/irregular admission.

AND WHEREAS, the State Government has requested to take necessary action against the Management as per the rules in force. The present institution has got admission for 15 extra seats as per the above letters of the State Government.

AND WHEREAS, the SRC in its 209<sup>th</sup> Meeting held on 31<sup>st</sup> July 2011, considered the matter and decided to issue show cause notice. Show cause notice was issued to the institution on 07.10.2011. The institution has submitted its written representation on 09.11.2011 along with relevant documents.

AND WHEREAS, the SRC in its 218<sup>th</sup> Meeting held on 28<sup>th</sup> February 2015, considered the matter and decided that, in view of the condonation ordered by the State Govt. SRC may warn the earrings institution and require them to give an undertaking that there will be no recurrence of such lapse.

AND WHEREAS, a letter was issued to the institution on 06.06.2012.

AND WHEREAS, a letter dated 16.03.2015 received by this office on 25.03.2015, from Director of School Education, Telangana, Hyderabad regarding grant of renewal of Temporary provisional Affiliation for the year 2014.15 in respect of certain private Diploma in Elementary Teacher Education in Telangana State.

AND WHEREAS, the SRC in its 289<sup>th</sup> Meeting held on 23<sup>rd</sup> June 2015, the committee considered the matter, letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad in respect of certain private Diploma in Elementary Teacher Education (43 colleges) not fulfilling the deficiencies and decided as under:

1. Issue show cause notice for withdrawal of recognition citing the deficiencies listed by the affiliating body.
2. Send a copy for information to the affiliating body.

AND WHEREAS, show cause notice was issued to the institution on 16.09.2015. The institution has submitted its written representation on 15.09.2015, 14.10.2015 and 28.10.2015 along with shifting fee for both courses and other relevant documents for shifting premises.

AND WHEREAS, the SRC in its 293<sup>rd</sup> meeting held on 29<sup>th</sup>, 30<sup>th</sup> & 31<sup>st</sup> October, 2015 considered the matter and decided as under:

- Fire certificate has been submitted. Close the case under intimation to the SCERT.

AND WHEREAS, letter was issued to the Director SCERT on 25.03.2016.

AND WHEREAS, the institution has submitted written representation on 26.02.2016. SRC in its 305<sup>th</sup> meeting held on 25<sup>th</sup> to 27<sup>th</sup> February, 2016 considered the matter and decided to "*Cause inspection for shifting & inform SCERT for admissions*".

AND WHEREAS, inspection intimation was sent to the institution and VT members on 17.03.2016. The inspection of the institution was conducted on 26.03.2016 and VT report along with documents received on 28.03.2016.

AND WHEREAS, the SRC in its 308<sup>th</sup> meeting held on 28<sup>th</sup> – 30<sup>th</sup> March, 2016 considered the VT report and it has decided to "*Permit shifting*".


NOW THEREFORE, permission is hereby accorded to Mother Mary College of Education(APS00252) & Mother Mary Elementary Teacher Training Institution(APS02615), Plot No.101, Chintal, Narketpally, Nalgonda District – 508116, Telangana to shift its premises to new location/building at Mother Mary College of Education(APS00252) & Mother Mary Elementary Teacher Training Institution(APS02615), Sy.No. 377, Chityala Village & Mandal, Nalgonda Division, Nalgonda District – 508114, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
