WHEREAS, Mandyam Educational Society, Chittoor, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Muni Venkata Subba Reddy College of Education, D.No. 19-9-3 E/5, Mother Land, Thiruchanoor By Pass Road, Tirupati, Chittoor -517501, Andhra Pradesh for conducting B.Ed course with an annual intake of 100 students and was granted recognition on 17.09.2010

AND WHEREAS, on 26.02.2015, an affidavit from the Principal, Muni Venkata Subba Reddy College of Education, D.No. 19-9-3 E/5, Mother Land, Thiruchanoor By Pass Road, Tirupati, Chittoor -517501, Andhra Pradesh dated 28.02.2015, was received by this office regarding submission of Affidavit based on the revised norms of Regulations, 2014.

AND WHEREAS, a Provisional Revised order was issued to the institution on 29.05.2015

WHEREAS, Mandyam Educational Society Plot No -19-9E/5 Tiruchanoor Road, Tirupati Village, Head Post Office, Tirupati Rural Taluk, Chittoor District-517501, Andhra Pradesh has applied for grant of recognition to M V S R Master Of Educational Colege Plot No -9-147/1A 1st Main Road, Damineed Village, Head Post Office, Tirupati Rural Taluk, Chittoor District-517501, Andhra Pradesh for offering M.Ed course of 2 years duration for the academic session 2016-17 under Section 14/15 of the NCTE Act, 1993 to the Southern Regional Committee, NCTE through online on 29.05.2015. The institution has submitted hard copy of the application on 12.06.2015.

AND WHEREAS, the application is processed as per NCTE (Recognition Norms and Procedures) Regulations, 2014 notified by NCTE on 01.12.2014. A letter for recommendation of State Govt. was sent on 22.06.2015 Followed by recommendation 27.10.2015 and reminder II on .2015 The Sub Section (7) of Section 7 of Regulations, 2014 for processing of applications stipulates as under:

"After consideration of the recommendation of the State Government or on its own merits, the Regional Committee concerned shall decided that institution shall be inspected by a team of experts called visiting team with a view to assess the level of preparedness of the institution to commence the course".

AND WHEREAS, the SRC in its 297th meeting has considered the matter, documents submitted by the institution along with hard copy of application and decided as under

2. They have shifted B.Ed without permission. Ask VT to inspect B.Ed in all aspects so that we have full information to consider ratification of the shifting done without permission.
3. Proof of NAAC accreditation and original FDRs to be collected in particular.
