ORDER**

WHEREAS, Muduganti Suryamma Hanmantha Reddy Educational Society, Adilabad, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Muduganti Suryamma College of Education, No.7/293/1, Rajampet, Asifabad District, Adilabad, Andhra Pradesh for B.Ed course. The recognition was granted to the institution on 12.04.2007 with an annual intake of 100 students with a condition that the institution shall shift to its own premises/building within three years from the date of recognition (in case the course is started in rented premises).

AND WHEREAS, the institution has submitted its willingness affidavit on 20.01.2015 as per regulations 2014.

AND WHEREAS, in the meantime, the institution has submitted its written representation on 25.02.2015 along with DD of Rs.50.000/- and relevant documents.

AND WHEREAS, revised recognition order was issued to the institution on 11.05.2015 with a condition that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 12.04.2007.

AND WHEREAS, The institution has submitted its written representation on 29.06.2015.

AND WHEREAS, a letter was sent to the institution on 29.06.2015 regarding request to resubmit a revalidated Demand draft. The institution has submitted revalidated DD of 50.000/- on 12.08.2015 bearing no.392536 dated 16.07.2015.

AND WHEREAS, the documents submitted for processing of shifting application is processed and placed before SRC in its 298th meeting held on 08th -10th January, 2016 considered the letter dated 12.08.2015 from the institution and decided as under:

1. Collect full fee for inspection for B.Ed shifting.
2. Cause Inspection.
3. Ask VT to collect remaining documents.

AND WHEREAS, as per the decision of SRC, inspection of the institution was fixed between 10th-30th January, 2016 the same was intimated to the institution on 16.01.2016.

AND WHEREAS, as per the direction of SRC, the inspection of the institution was conducted on 25.01.2016 and the VT Report along with documents received in the office of SRC on 27.01.2016.

AND WHEREAS, the SRC in its 302nd Meeting held on 09th-11th February, 2016 considered the VT report and relevant documents submitted by the institution on 30.01.2016 and it has decided to **shifting permitted**.

NOW THEREFORE permission is hereby accorded to **Muduganti Suryamma College of Education, No.7/293/1, Rajampet, Asifabad District, Adilabad, Andhra Pradesh for B.Ed (APS05721)** to shift to its premises to the new location/Building at **Muduganti Suryamma College of Education, H.No. 3-192, Buruguda Village, Asifabad Madnal, Adilabad District-504293, Telangana.**

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
