ORDER

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

**2. AND WHEREAS**, the institution, Navodhaya College of Education, Plot/Khasara No. 188/3, Kodiyalam, Kothapally T Village, Sevagangapally Post, Hosur Taluk, Dharmapuri District-635103, Tamilnadu has by affidavit consented to come under New Regulations and sought for two basic units in B.Ed which require additional facilities

**3. AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017

**4. NOW THEREFORE**, in the light of the above and in terms of Section 14(3) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby grants recognition to Navodhaya College of Education, Plot/Khasara No. 188/3, Kodiyalam, Kothapally T Village, Sevagangapally Post, Hosur Taluk, Dharmapuri District-635103, Tamilnadu for conducting B.Ed programme of two years duration with an annual intake of 100 students each for two basic units from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015

**5.** Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.

**6.** The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.

7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made of issued there under , the institution will render itself vulnerable to adverse action including withdrawal of recognition by the regional committee under the provisions of Section 17(1) of the NCTE Act.

**ORDER**

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Sri Sathagiri Education Trust, Plot No. 188/3, Bagalur Sarjapur Main Road, Kothapally T Village, Sevaganapally Post, Hosur Taluk, Dharpuri District, Pin-635103, Tamilnadu had submitted an on-line application to the Southern Regional Committee of NCTE on 29.09.2011 and physical application on 05.10.2011 for grant of recognition for B.Ed course of one year duration with an annual intake of 100 students at Navodhaya College of Education, Plot/Khasara No. 188/3, Street No. 188/3, Kodiyalam, Kothapally T Village, Sevaganapally Post, Hosur Taluk, Dharpuri District, Pin-635103, Tamilnadu

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE in its 231<sup>st</sup> meeting held on 22<sup>nd</sup>-23<sup>rd</sup> August, 2012 hereby grants recognition to Navodhaya College of Education, Plot/Khasara No. 188/3, Street No. 188/3, Kodiyalam, Kothapally T Village, Sevaganapally Post, Hosur Taluk, Dharpuri District, Pin-635103, Tamilnadu for conducting B.Ed Course of one year duration with an annual intake of 100 students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject to fulfillment of the following conditions:

- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
  - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
  - V. Minority Certificate from the Principal Secretary, Department of Education, Government of Tamilnadu to be submitted within 3 months from the date of issue of this order.
2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable.


