ORDER**

WHEREAS, Nalanda Educational Society, Gutta, Mahabubnagar, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE seeking permission to start Nalanda Teacher Training Institute, 1-10-14/1/F3, Shasabgutta, Mahabubnagar District-509001, Andhra Pradesh for Elementary (D.Ed) Course of two years duration from the academic session 2005-06 with an annual intake of 50 students.

AND WHEREAS, the recognition was granted to the institution on 26.08.2005 with a condition that the institution shall shift both B.Ed & D.Ed courses to its own premises/building within three years from the date of recognition of B.Ed college as the recognition for D.Ed is issued based on existing of B.Ed college and notification dated 01.01.2004 of NCTE. (in case the B.Ed/D.Ed course is started in rented premises).

AND WHEREAS, letter dated 09.05.2014 received from SCERT was received on 30.05.2015 regarding verification of staff lists for D.Ed course of Private D.Ed college – Approval of staff list or otherwise in respect of Nalanda Teacher Training Institute (D.Ed) Malleboinpally, Jadcherla, Mahabubnagar District.

AND WHEREAS, letter.No.60/N1-3/2014 Dt.16.03.2015 received from Director of School Education, Government of Telangana on 25.03.2015 regarding grant of renewal temporary provisional affiliation for the year 2014-15 in respect of certain private Diploma in Elementary Teacher Education in Telangana state –deficiencies not fulfilled including (Nalanda Teacher Training Institute, 1-10-14/1/F3, Shasabgutta, Mahabubnagar District (D.Ed & B.Ed). The letter stated as follows:

"I wish to inform that as per Affiliation Committee recommendations and after approval of the Government of Telangana, Renewal of Temporary provisional affiliations have been issued to all the Private Diploma in elementary Teacher Education Colleges in the State for the year 2014-15 vide ref. 5th cited (C & DSE Telangana, Hyd, Procs. No.172/N1-3/scert/14 dt. 20-10-2014.) subject to fulfillment of deficiencies pointed out therein and rectify the defects such as NOC from District Fire Officer, required land area, 1+7 approved staff, 1000 library books etc. on or before 31st January, 2015 failing which the NCTE Bangalore will be addressed for withdrawal of recognition for the next academic year 2015-16. But so far (43) managements annexure-II appended to this letter have failed to comply to rectify the deficiencies.

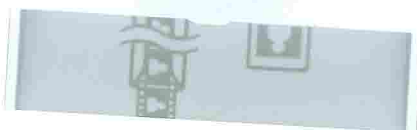
In view of the above I request you to initiate necessary action for withdrawal of recognition for these (43) colleges as per rules.

I enclose herewith a copy of list of (43) colleges Annexure-II

This has got the approval of Director of School Education, Telangana State Hyderabad".

AND WHEREAS, the SRC in its 289th meeting held on 23 June, 2015 considered the letter dated 16.03.2015 from Director of School Education, Govt. of Telangana, Hyderabad, in respect of certain private Diploma In Elementary Teacher Education (43 colleges) not fulfilling the deficiencies and the committee decided as under:

1. Issue Show Cause Notice for withdrawal of recognition citing the deficiencies listed by the affiliating body.
2. Send a copy for information to the affiliating body.

AND WHEREAS, show cause notice was issued to the institution to the institution (Both B.Ed and D.Ed) with a copy to affiliating body on 16.09.2015 for the following deficiency:

- 1+6 approved staff list is submitted.

AND WHEREAS, the institution has submitted two written representations on 19.10.2015 along with relevant documents and stating as follows:

"the management of Nalanda Educational Society, SS Gutta, Mahabubnagar shifted both the B.Ed & D.Ed colleges to its own building situated at Malleboinpally Village of Jadcherla Mandal as per your directions and the inspection team also inspected the building. The B.Ed and D.Ed courses have been running in the present campus right from 2006-2007 onwards.

The requisite amount Rs. 40,000/- was also paid vide D.D.No. 040836 Dt. 14.09.2009 and submitted in your office on 15.09.2009 along with necessary documents, but the shifting of building permission orders are pending in your office since 2009 (as mentioned in the para:3 of your office letter shown under reference. 2).

I once again request you to consider the case and accord permission for shifting of building".

The written representation dated 19.10.2015 stated as follows:

"I submit that the both D.Ed and B.Ed colleges managed by Nalanda Educational Society, SS Gutta, Mahabubnagar (TS) have been shifted to its own building situated at Malleboinpally Village of Jadecherla Mandal, Mahabubnagar Dist. The inspection was also conducted by the inspection committee on 09.02.2011, but the permission for shifting of building is pending at your office.

Therefore I request you to issue directions to TSCERT Hyderabad to consider the case for renewal of affiliation of D.Ed (Nalanda TTI) for the academic year 2015-2017".

AND WHEREAS, the institution has submitted another written representation on 26.10.2015 along with a copy of the SCN reply dated 11.11.2011 and documents and stating as follows:

"... I submit that few lines for your information and kind consideration.

The nalanda Educational Society was already submitted a compliancy report to above said show cause notice with in stipulated time that in on 11.11.2011.

However here I am submitting the same then copy of compliancy report for your kind consideration and favor of action".

AND WHEREAS, the SRC in its 293rd meeting held on 29th, 30th, & 31st October, 2015 considered the matter and it has decided as under:

- Put up in the next meeting for further action.
- In the meanwhile request the affiliating bodies to renew the affiliation.

AND WHEREAS, the institution has submitted its reply to the show cause notice dated 16.09.2015 on 19.10.2015 and 23.11.2015 along with documents.

AND WHEREAS, letters to TSCERT, Telangana and Osmania University sent on 14.12.2015.



AND WHEREAS, the institution has submitted its written representation along with relevant documents on 15.02.2016 requesting for shifting the premises.

AND WHEREAS, the SRC in its 303rd meeting held on 15th February, 2016 considered the written representation of the institution along with relevant documents and decided to "Permit shifting".

NOW THEREFORE, permission is hereby accorded to Nalanda Teacher Training Institute, 1-10-14/1/F3, Shasabgutta, Mahabubnagar District-509001, Andhra Pradesh (APS02528 - D.Ed) to shift its premises to new location/building at Nalanda Teacher Training Institute, Sy.No. 32, 33, Malleboinpally Village, Jadecherla Mandal, Mahabubnagar District – 509301, Andhra Pradesh.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
