WHEREAS, St. Mary's Educational Society, Nalgonda Dt., Andhra Pradesh has submitted an application to SRC-NCTE for grant of recognition to Narketpally College of Education, LIG-2, APHB Colony, Nalgonda District-508001, Andhra Pradesh for B.Ed course.

AND WHEREAS, the application was processed as per the provisions contained in Rules and Regulation, Norms and Standards vogue at that point of time and the recognition was granted to the institution vide order dated 08.03.2005 with stipulated conditions.

AND WHEREAS, the society submitted an application for M.Ed. course vide dated 10.5.2007 to the office of SRC. The same was processed and re-inspection of the institution was conducted on 12.3.2009. While considering the written representation for M.Ed. course, the SRC also decided to issue notice under Section 17 for existing B.Ed. Consequent upon the decision taken by SRC-NCTE the show cause notice was issued to the institution on 5.6.2009.

AND WHEREAS, the institution submitted its reply on 1.7.2009. The Committee considered the written representation along with documents and has decided to withdraw recognition to the institution for the following reasons:-

- The institution was accorded recognition on 8.3.2005 in rented premises at LIG-2, APHB Colony, Nalgonda with the condition that the institution shall be shifted to its own premises/building within three years (7.3.2008) from the date of recognition order issued. The institution has not constructed its own building to shift B.Ed. course as per stipulated conditions of recognition order. Hence, the institution is not eligible to continue in the rented premises as per the rules, regulations, Norms and standards of NCTE.
- The institution was shifted to a leased building at 1-14 Survey No.14, Miryalaguda Byepass road, Miryalaguda P.O. and Village, Nalgonda Mandal and Revenue Division of Nalgonda Dt. without prior approval of the Regional Committee as per para 8(11) of regulations of NCTE, 2007. It is further observed that land measurement in the lease deed is 2,032 sq.mtrs. and construction as per schedule of the property is made for residential purpose. The land area is insufficient and the building is not suitable to run B.Ed. course.
- The SRC also took note of the fact that the institution has shifted to another leased premises without taking permission from NCTE, where inadequate land and house was built up as per lease and has not shifted to its own building as per regulations of NCTE Act, 2007.

AND WHEREAS, recognition granted to the Institution was withdrawn under Section 17 of NCTE Act for B.Ed course from the academic session 2009-10 vide order dated 24.07.2009

AND WHEREAS, However, the ongoing batch of students be permitted to complete their course (The students admitted in 2008-09 be allowed to continue in order to complete the course). The institution shall not make any fresh admission subsequent to the withdrawal order. The State Government and affiliating University may be informed accordingly.

AND WHEREAS, after that the institution has approached the Appellate Authority, New Delhi where in the appellate authority has directed that appeal was rejected and SRC's order dated 24.07.2009 was confirmed".

AND WHEREAS, the institution has approached the Hon'ble High Court of Andhra Pradesh at Hyderabad in W.P.No.29059 of 2009. The Court order dated 31.12.209 states as under:-

"There shall be suspension of the impugned order dated 26.11.2009 passed by 1st respondent in rejecting the appeal filed by the petitioner confirming the orders passed by the 2nd respondent vide proceedings F.SRO/NCTE/Ref/2009-10/14777 dated 24.07.2009. However, it is directed that the petitioner shall be entitled to run the B.Ed College in the next academic year, only after the premises in which the college is to be located is approved by the competent authority.

AND WHEREAS, in this context it is informed that as per appellate order no 89-1170/2009-Appeal/A-7236 dated 26.11.2009, the effect of withdrawal order was made from the academic session 2010-2011 instead of session 2008-2009."

AND WHEREAS, the SRC in its 188th meeting held on 28-29 January 2010 noted the above and has decided to inform the NCTE Counsel to pursue the case. The Committee also decided to await the disposal of the case. Simultaneously, Headquarters was informed of the status. The concerned affiliating university and the State Government be informed of the Court Order that "the petitioner (institution) shall be entitled to run the B.Ed college in the next acedemic year (2010-11) only after the premises in which the College is to be located is approved by the competent authority (SRC, NCTE). The institution shall not make admission till the Court Orders are complied with.

AND WHEREAS, the institution has approached to Hon'ble High court in writ petition no. 37687/2009 in writ petition no. 29059. The Hon'ble High court has directed as under:-

"Learned counsel appearing for the petitioner submits that an application has been filed before the 2nd respondent with a request to conduct inspection of the petitioner college and the same is pending consideration.

In view of the matter there shall be interim direction to the 2nd respondent to inspect the petitioner college on payment of inspection fee, if any, within six weeks from today"

AND WHEREAS, the institution has submitted inspection fee of Rs.40000/- on 15.07.2010.

AND WHEREAS, the matter was considered by the Committee and it was decided to cause inspection of the institution for B.Ed. Course, under Section 17 of NCTE Act, after payment of Rs.40,000/- inspection fee and on submission of filled in Questionnaire, along with relevant supporting documents relating to building, land, including Building Completion Certificate from the competent Government Engineer and Land Use Certificate, within four weeks from the date of confirmation of the Minutes.

AND WHEREAS, accordingly VT inspection was carried out on 03.09.2010.

AND WHEREAS, the SRC in its 196th meeting held on Committee considered the VT report, VCD and other related documents along with the original file and decided to continue recognition accorded to the institution.

AND WHEREAS, accordingly, continue recognition order was issued to the institution on 20.09.2010.

AND WHEREAS, in the meantime, a court notice in W.P.No.31925 of 2011 received on 21.12.2010. Writ petition filed against RD-SRC-NCTE, State Council of Higher Education, Convenor, Ed-CET 2011, Mahatma Gandhi University.

AND WHEREAS, the institution has submitted its written representation on 21.08.2012 regarding correction in address given in recognition order.

AND WHEREAS, accordingly, corrigendum was issued to the institution on 22.08.2012.

AND WHEREAS, the institution has submitted its written representation on 29.01.2015 along with willingness affidavit as per regulation 2014.

AND WHEREAS, accordingly, revised recognition order was issued to the institution on 12.05.2015 with a condition that the institution has not maintained the FDR towards Endowment & Reserve funds.

AND WHEREAS, the institution has submitted original FDRs on 06.07.2015. After verification of original FDRs, FDRs are returned to institution on 06.07.2015.

AND WHEREAS, the institution has submitted its written representation on 24.09.2015 along with photocopies of recognition order copies. In its letter stated as follows:-

"....the visiting team report was placed before the SRC in 196th meeting held on 15-16 September 2010. The committee considered the report and decided to continue the recognition of the institution SRC order dt. 08.03.2005 to B.Ed course.

Now therefore, the recognition of the college has been restored. So at the time of formal recognition vide order F.SRO/NCTE/2010-11/21209 issued dt. 20.09.2010 not mentioned the shifting from leased to own premises. According to SRC, NCTE order dt. 20.09.2010, we request you to issue shifting order as soon as possible.

AND WHEREAS, the SRC in its 292nd meeting held on 29-30 September, 2015 considered the institution written representation and it has decided as follows:-

"Inspection for shifting caused. Allowed ready to function in new premises. In SRC's 196th meeting shifting order not issued. Issue now.

NOW THEREFORE, Narketpally College of Education, LIG-2, APHB Colony, Nalgonda District-508001, Andhra Pradesh for B.Ed course is hereby permitted to shift to new address i.e. Narketpally College of Education, Village, Cherlapally, Hyderabad Road, Nalgonda District-508001, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition Norms and Standards) 2014 as notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Recognition, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
