ORDER

WHEREAS, Panchasheela Educational Society, Kadapa District, Andhra Pradesh had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Panchasheela College of Education, No. 7/1376, Korapadu Road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh for Secondary (B.Ed) course of one year duration with an annual intake of 100 students. and was granted recognition on 27.08.2007 with condition of Shift to its own premises/ building within three years from the date of recognition (in case the course is started in rented premises)

AND WHEREAS, on 20.01.2015, an affidavit from the Principal, Panchasheela College of Education, No. 7/1376, Korapadu Road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh dated 21.01.2015, was received by this office regarding submission of Affidavit based on the revised norms of Regulations, 2014.

AND WHEREAS, the Provisional revised order issued to the institution on 29.05.2015.

AND WHEREAS, Panchasheela Educational Society, Plot No. 528 529, Ring Road, Kottapalli Village & Post Office, Proddatur Taluk & City, Kadapa District-516 360, Andhra Pradesh has applied for grant of recognition to Kodanda Ramaiah Memorial College of D.ED. Plot No. 528 529, Ring Road, Kottapalli Village & Post, Proddatur Taluk & City, Kadapa District-516 360, Andhra Pradesh for offering D.El.Ed-AI course of Two years duration for the academic session 2016-17 under Section 14/15 of the NCTE Act, 1993 to the Southern Regional Committee, NCTE through online on 30/05/2015. The institution has submitted hard copy of the application on 08/06/2015.

AND WHEREAS, the application is processed as per NCTE (Recognition Norms and Procedures) Regulations, 2014 notified by NCTE on 01.12.2014. A letter for recommendation of State Govt. was sent on 17/06/2015 Followed by reminder-I 26/08/2015 and reminder II on 09/11/2015.

AND WHEREAS, the Sub Section (7) of Section 7 of Regulations, 2014 for processing of applications stipulates as under:

"After consideration of the recommendation of the State Government or on its own merits, the Regional Committee concerned shall decided that institution shall be inspected by a team of experts called visiting team with a view to assess the level of preparedness of the institution to commence the course".

AND WHEREAS, the SRC in its 296th meeting held during 15th, 16th December, 2015 consider the matter, document submitted by the institution for D.El.Ed-AI (SRCAPP3049) Course along with hard copy of application and decided as under :-

1. **Encumbrance Certificate to be submitted.**
2. **Original Fixed Deposit Receipts to be submitted.**
3. **Ask VT to obtain relevant Land and Building documents.**
4. **Cause Composite inspection.**

AND WHEREAS, as per the decision of SRC, a Composite inspection the institution was conducted on 22.02.2016 and Visiting Team report is received by this office on 25.02.2016.

AND WHEREAS, as per the decision of SRC, in its 305th meeting held during 25th to 27th February, 2016 consider the matter and decided as under:-


1. **Permit shifting B.Ed APSO6340**
2. **Issue LOI for D.El.Ed-AI (1 Unit).**
3. **For D.El.Ed (basic unit) and D.El.Ed-AI combined staff list should be produced in accordance with the norms given in 2014 Regulations.**
4. **FDRs in Joint account should be furnished.**
5. **Only if these are given on or before 3.3.16 can issue of Formal Recognition w.e.f.2016-17 academic year be possible.**

AND WHEREAS, the Southern Regional Committee in its 305th meeting held during 25th to 27th February, 2016 considered the VT report and decided as **permit shifting to new premises.**

NOW THEREFORE, permission is hereby accorded by SRC to Panchasheela College of Education No. 7/1376, Korapadu Road, Proddatur Mandal, Kadapa District-516360, Andhra Pradesh to shift its premises to the new location / building at Kodanda Ramaiah Memorial College of D.ED. Plot No. 528 529, Ring Road, Kottapalli Village & Post, Proddatur Taluk & City, Kadapa District-516 360, Andhra Pradesh.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
