PREAMBLE:-

**SNRP Educational Society, Hyderabad, Andhra Pradesh** has submitted an application to the SRC of NCTE for grant of permission for conducting D.Ed course to **Presidency College of Education, H.No.19-3-159, Jahanuma, Near Falaknuma Bus Depot, Hyderabad, Andhra Pradesh** has granted recognition for B.Ed course on 01-05-2007. The Deficiency reply of B.Ed courses i.e. (SRCAPP1885) was placed before the SRC in its 247<sup>th</sup> Meeting held on 20<sup>th</sup> – 22<sup>nd</sup> July, 2013 and the Committee directed the SRO to put up a comparative chart in the 248<sup>th</sup> Meeting for all the 4 courses – B.Ed (SRCAPP1885), B.Ed (APS07049), B.Ed (SRCAPP857), D.Ed (APS07048).

Accordingly, comparative for all the 4 courses – B.Ed (SRCAPP1885), B.Ed (APS07049), B.Ed (SRCAPP857), D.Ed (APS07048) was processed by a comparative chart for all the 4 courses was placed before the committee.

The SRC in its 247<sup>th</sup> meeting held on 20<sup>th</sup>-22<sup>nd</sup> July 2013 and the committee directed the SRO to put up a comparative chart in the 248<sup>th</sup> meeting for all the courses of B.Ed(SRCAPP1885), B.Ed (APS07049), B.Ed (SRCAPP857), D.Ed (APS07048) Accordingly, a comparative chart for all the 4 courses was placed before the committee.

The Southern Regional Committee in its 250<sup>th</sup> meeting held during 11-13 august 2013 considered the matter and all the relevant documentary evidences and it was decided to withdraw recognition for D.Ed.(APS07048) and B.Ed.(APS07049) w.e.f 2013-14 and from 2014-15 respectively for the following deficiencies:-

- The institution has not submitted the Building Completion Certificate, Land Usage Certificate and Non- Encumbrance Certificate

Based on the above points the committee decided to withdraw the recognition of the D.Ed. (APS07048) and B.Ed. (APS07049) run by S.N.R.P Educational Society from the academic year 2013-14 and 2014-15, in order to enable the ongoing batch of students, if any, to complete their course.

It was made clear that the institution is debarred from making any further admission subsequent to the date of issue of this order. The Affiliating body / Examining board / body be informed accordingly. Further decided to return Endowment funds and reserve fund deposited with SRC NCTE, Bangalore if any.

As per the decision of SRC a withdrawal order was issued to the institution vide order No.F.No.APSO7049/D.Ed (2013-14)/54109 dated 30.09.2013.

Aggrieved by withdrawal order. The institution had Preferred an appeal before the appellate authority, NCTE hqrs.

The appellate authority vide order F.No.89-640/2014appeal /8<sup>th</sup> meeting-2014 A 137025 date 21-07-14 stated as under:-

"Shri MA Qayum Khan, Secretary, Presidency College of Education, Hyderabad, Andhra Pradesh presented the case of the appellant institution on 04-01-2014. In the appeal and during personal presentation it was submitted that the institution has submitted building completion certificate as per format given by SRO, Land Use Certificate and Non Encumbrance certificate along with the mandatory information as per SRO letter No. SRO/NCTE/2009-2010/14035 dated 12-06-2009 on 20-07-2009 and the receipt of which was also acknowledged. Copies of building completion certificate, Land use Certificate and non Encumbrance Certificate is enclosed for your ready reference again. i) The appellant with the appeals in respect of B.Ed. and D.Ed. has enclosed only the copy of the withdrawal order issued in respect of D.Ed. course. ii) Both the files of SRC contain only the withdrawal orders in respects of D.Ed. course. There is no copy of the withdrawal in respect of B.Ed. in SRC's file. iii) This needs clarification from SRC

The Council in their meeting held on 30/05/2014 noted that the SRC has not sent any clarification so far. In the circumstances the Council concluded that the matter deserved to be remanded to SRC with a direction to consider the submissions of the appellant on the file of B.Ed course and take a fresh decision. In the meanwhile the withdrawal order shall be kept in abeyance.

After perusal of the memorandum of appeal, affidavit, documents available on records and considering the oral arguments advanced during the hearing, the Council concluded that the appeal deserves to be remanded to SRC with a direction to consider the submissions of the appellant on the file of B.Ed course and take a fresh decision. In the meanwhile the withdrawal order shall be kept in abeyance.

The Council hereby remands back the case of Presidency College, Hyderabad to the SRC, NCTE, for necessary action as indicated above,

The Southern Regional Committee in its 276<sup>th</sup> meeting held during 7<sup>th</sup> 9<sup>th</sup> January 2015 considered the matter decided and advised Southern Regional Office to process the case after Notification of new Regulations.

The institution had submitted the affidavit on 01.01.2015:

The Southern Regional Committee in its 276<sup>th</sup> meeting held during 7<sup>th</sup> 9<sup>th</sup> January 2015 considered the matter, reply of the Institution dated 01.01.2015 along with affidavit expressing their willingness to process their application as per Regulations 2014, decided and advised Southern Regional Office to:

- 1. Restore recognition**
- 2. Issue revised provisional recognition order.**
- 3. Verify in October 2015**
- 4. Inspect thereafter.**

As per the decision of SRC, the recognition of the Institution has been restored and revised provisional order is prepared as under.

**ORDER**

**WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. **AND WHEREAS**, on scrutiny it is found that the institution has not maintained/revalidated the Fixed Deposited Receipts towards Endowment and Reserve Funds.

3. **AND WHEREAS**, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely,

- (i). The institution shall submit revalidated FDRs of the enhanced values, in joint account with the SRC before 30 June, 2015 failing which the recognition will be withdrawn.
- (ii). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015
- (iii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate(EC), Land Use Certificate(LUC) and the Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- (iv). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. **NOW THEREFORE**, in the light of the above and in terms of Section 14(3) (a) of NCTE Act and in accordance with the Regulations, 2014, the Southern Regional Committee, NCTE hereby restores recognition of **Presidency College of Education, H.No.19-3-159, Jahanuma, Hyderabad-500023, Andhra Pradesh** for conducting B.Ed programme of **two** years duration with an annual intake of **100** for two basic units of 50 Students from the academic session **2015-16**.

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.



7. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information, if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act
