Preamble:

Read: Notification of NCTE, New Delhi dated 1.1.2004 published in the Gazette of India Part III-Section 4 as No. 3 on 5.1.2004.

The NCTE, New Delhi in its Notification dated 01.01.2004 decided to dispense with the requirement of "No Objection Certificate" from State/UT Government for those institutions already running Elementary programmes recognized by NCTE and seeking recognition to start a course or training in increase in intake for a period of three years from the date of notification of these regulations in the Official Gazette.

Punitha OHM Teacher Training Institute, Velayuthapuram, Sattur Road, Kovilpatti, Tuticorin – 628501, Tamilnadu which has been granted recognition by SRC-NCTE has submitted an application for increase in intake for Elementary (D.T.Ed) course by deriving the benefit of above said regulation on 28.12.2004.

The application for increase in intake of Punitha OHM Teacher Training Institute, Velayuthapuram, Sattur Road, Kovilpatti, Tuticorin – 628501, Tamilnadu was considered by SRC-NCTE under section 15 of NCTE Act, 1993. Accordingly, inspection of the institution was carried out on 11.10.2005 and the report of inspection team and other documents furnished by the institution along with the application were considered by the Southern Regional Committee in its 104th meeting held on 8th and 9th October, 2005. The Regional Committee observed that the institution had made satisfactory arrangements in respect of infrastructural and instructional facilities for proposed increase in intake and decided to permit the institution with an additional intake of 50, thus making the total intake capacity of 100 from the session 2005-06. Hence the order.

In terms of section 15(1) of the NCTE Act, 1993 **Punitha OHM Teacher Training Institute, Velayuthapuram, Sattur Road, Kovilpatti, Tuticorin – 628501, Tamilnadu** had submitted an application to the Southern Regional Committee of NCTE for grant of permission for increase in intake of Elementary(D.T.Ed) course of two years from the academic session **2005-06** with an additional intake of **50** students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a. The institution has acquired the land for setting up the teacher education institution.
- b. The institution has selected the **Principal** and **Eleven** teachers for the said course, which is to be approved by the Director, DTERT, Chennai.

3. Now, therefore, in exercise of the powers vested under Section 15(1) of the NCTE Act, 1993, the Southern Regional Committee hereby grants permission to **Punitha OHM Teacher Training Institute, Velayuthapuram, Sattur Road, Kovilpatti, Tuticorin - 628501, Tamilnadu** for Elementary(D.T.Ed) course of **two years duration** from the academic session **2005-06** with an annual intake of **100** students which includes the existing intake of **50** and an additional intake of **50**, subject to fulfillment of the following.

- a. The institution will ensure that **Twelve** exclusive faculty members (**Principal and Eleven teachers**) duly approved by the DTERT are in position for an intake of **100** students and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case before commencement of admissions for the course
- b. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- c. FDR for endowment fund should be converted in the joint name of the Regional Director, SRC-NCTE and the management represented if it is not already done.
- d. The institution should move to their own building within three years from the date of recognition of teacher training institute.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of Teacher Education Research and Training (DTERT) to the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
