PREAMBLE:

Pushpageeth School for Teacher Education, Madhavam Foundation, Elaneri, Kottoor P.O., Trivandrum, Kerala has made application for grant of recognition for Elementary course of two year duration to Southern Regional Committee on 31.12.2003.

On scrutiny of the application it was found that application was complete and essential documents as required under regulations were submitted.

Accordingly, visiting team was deputed on 23.03.2004 to assess the infrastructural and instructional facilities available in the institution. The visiting team report was placed before 78th meeting of SRC held on 24th and 25th June 2004 and SRC decided to issue notice on 05.07.2004 stating the following deficiencies

- ❖ Except land and the basement infrastructure, nothing is available either on records or for physical verification.
- ❖ Staff list is not approved by the Director, SCERT, Thiruvananthapuram.

The written representation of the institution dated 29.07.2004 was placed before 79th meeting of SRC held on 29-30 July 2004 and SRC decided to reject the proposal for starting Elementary course. Hence, Rejection orders were issued on 06.08.2004 with the following deficiency

- ❖ Except land and the basement infrastructure, nothing is available either on records or for physical verification.
- ❖ Staff list is not approved by the Director, SCERT, Thiruvananthapuram.

The applicant institution proffered appeal before NCTE, New Delhi against the rejection order issued by this office on 06.08.2004. The Appellate Authority considered the appeal and passed order 13th October 2004 and confirmed the rejection orders of SRC-NCTE for the session 2004-2005 and directed SRC-NCTE to consider the case for the session 2005-2006. Accordingly a visiting team was deputed on 14.05.2005 to assess the infrastructural and instructional facilities and the claims made by the institution. The visiting team report was placed before 94th meeting of SRC held on 24th June 2005. SRC decided to issue notice on 08.08.2005 with the following deficiencies:

- ❖ The institution has not identified the Principal
- ❖ There is no seminar hall

- ❖ Laboratory facilities are inadequate.
- ❖ The institution has not created the required Endowment and Reserve fund in the form of FDR's

Written representation dt.22.08.2005 for the notice was placed before 99th meeting of SRC held on 29th August 2005 and SRC decided to accord recognition.

Hence the following order

ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Pushpageeth School for Teacher Education, Madhavam Foundation, Elimala, Kottoor P.O., Trivandrum, Kerala had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting Elementary course with an intake of 50 students of two year duration from the academic session 2004-2005.

2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a) The institution has acquired the land for setting up the teacher education institution.
- b) The institution has created an Endowment Fund of Rs.5.00 Lakhs and a Reserve Fund of Rs. 1.50 Lakhs.
- c) The institution has selected the Principal / Head and five teachers for the said course and the staff list is approved by the Director, SCERT.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Pushpageeth School for Teacher Education, Madhavam Foundation, Elimala, Kottoor P.O., Trivandrum, Kerala for Elementary course of two-year duration from the academic session 2005-2006 with an annual intake of 50 students subject to fulfillment of the following.

- a) The institution will ensure that six exclusive faculty members (Principal/Head and fifteen teachers) are in position for an intake of 50 students and a report to this effect shall be sent to the Committee immediately and in any case before commencement of the admissions.
- b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
- c) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).

- d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
3. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC / University / State Government etc.,
4. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University for the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant
5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
