
CORRIGENDUM

4.	AND WHEREAS, the SRC has decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely, I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31 st July, 2015 failing which recognition will be withdrawn. II. The Regional Committees shall inspect the proposed premises during August-September-October, 2015 and if on inspection it is found that the institution dose not fulfill required norms of infrastructure recognition will be withdrawn. III. Further, with regard to the second unit the institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015. IV. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.	4. AND WHEREAS, the SRC has decided to permit the institution to have one basic units of 50 students each subject to the institution fulfilling following conditions namely, I. The institution shall submit all documents including land, building, Encumbrance Certificate, Land Use Certificate, Building Plan, approved staff list, pertaining to shifting to own premises to the SRC before 31 st July, 2015 failing which recognition will be withdrawn.
