WHEREAS in terms of Section 14(1) of the NCTE Act. 1993 Hanna Charitable Trust, Plot No.1-205, Yerramreddinagar Road, Rampachodavaram Village and Post, Rampachodavaram Taluk and City, East Godavari District-533288, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 29.09.2011 and physical application on 04.10.2011 for grant of recognition for D.EI.Ed course of two year duration with an annual intake of 50 students at Ratna Solomon College of Elementary Education, Plot/Khasara No.222, Street No.1-413/1/1, Krishnunipalem Village, Gokavaram Post and Taluk, Gokavaram City, East Godavari District-533286, Andhra Pradesh.

- III The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
- IV The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Covernment etc. as applicable
- The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.

  - d Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission etc.;
  - e Fee charged from students;
  - f Available infrastructural facilities;
  - g Facilities added during the last quarter;
  - h Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i The institution shall be free to post additional relevant information, if it so desires
  - j Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
- 5 If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
