ORDER

In terms of Section 15(1) of the NCTE Act, 1993 RAYALASEEMA COLLEGE OF PHYSICAL EDUCATION, RAYAVARAM, MYDUKUR ROAD, PRODDATUR — 516 362, KADAPA DT., ANDHRA PRADESH had submitted an application to the Southern Regional Committee of NCTE for grant of permission for starting M.P.Ed. Course of Two years duration from the academic session 2003-04 with an annual intake of 30 students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.

 The institution has constructed the building for conducting the course on the abovementioned land.
 - ii) The institution has created an Endowment Fund of Rs. 5.00 Lakhs and a Reserve Fund of Rs. 2,00,000/-
 - iii) The institution has selected the Principal / Head and 5 teachers for the said course.
- 3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants permission to RAYALASEEMA COLLEGE OF PHYSICAL EDUCATION, RAYAVARAM, MYDUKUR ROAD, PRODDATUR 516 362, KADAPA DT., ANDHRA PRADESH for M.P.Ed. Course of Two years from the academic session 2003-2004 with an annual intake of 30 students subject to fulfillment of the following:
 - a) The institution will ensure that **Principal & Four** faculty members duly approved by the affiliating body are in position for an intake of <u>30</u> students before commencement of the course and a report to this effect shall be sent to the Committee within one month of commencement of the course.
 - b) The institution shall, within one month of the receipt of order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.
 - c) The institution shall shift to its own premises within three years from the date of permission (In case the course is started in rented premises).

- The institution shall comply with the various other norms and standards prescribed in d) the NCTE Regulations and the institution shall be visited on any day after three months from the date of issue of permission order for ensuring its satisfactory performance.
- 4. Further, permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government, etc.
- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant
- 6. If the institution contravenes any of the above condition or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act.
