WHEREAS, Rahmans College of Education, Jangaon Revenue Division, Hyderabad Road, Jangaon, Warangal District-506167, Telangana was granted recognition for offering B.Ed course vide order dated 12.01.2004 and D.El.Ed course on 01.08.2005 with condition that the institution shall shift both B.Ed & D.Ed courses to its own premises within three years from the date of recognition(In case the course is started in rented premises).

AND WHEREAS, the institution has submitted shifting proposal on 20.09.2007 along with requisite fee of Rs. 40,000/- DD and some relevant documents.

AND WHEREAS, on 31.12.2014, a letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.

AND WHEREAS, the institution has submitted the affidavit for offering B.Ed course with an intake of 100 students on 20.01.2015.

AND WHEREAS, the SRC in its 276<sup>th</sup> meeting held on 7<sup>th</sup>-9<sup>th</sup> January, 2015 decided to issue provisional recognition orders to the existing institutions and the committee also decided to maintain a check list of such cases for verification in October/November and for causing inspection.

AND WHEREAS, the SRC in its 284th meeting held on 9th -0th April, 2015 decided as under:-

 On scrutiny it is found that the institution has not shifted to its own premises as stipulated in its Formal Recognition order dated 12.01.2004.

AND WHEREAS, a revised order was issued to the institution on 11.05.2015 with shifting condition. The institution has submitted its written representation on 27.07.2015 along with some relevant documents.

AND WHEREAS, the institution has submitted its written representation on 18.02.2016 along with some relevant documents which was placed before SRC in its 304<sup>th</sup> meeting held on 19<sup>th</sup> to 20<sup>th</sup> February 2016, the committee considered the matter and decided as follows;

- · Shifting fees difference to be paid.
- After receiving of shifting fees the application to be considered.

AND WHEREAS, the institution has submitted its written representation on 23.02.2016 along with shifting fee and approved staff list.

AND WHEREAS, the SRC in its 305<sup>th</sup> meeting held on 25<sup>th</sup> – 27<sup>th</sup> February, 2016 considered the shifting case and it has decided to "Cause inspection for shifting. Inform SCERT and University for admissions".
