WHEREAS, Rousseau College of Education, Siricilla Revenue Division, No. 3-4-179, Docotors Lane, Head Post Office, Karimnagar District - 505001, Andhra Pradesh has made an application for B.Ed Course to Southern Regional Committee, NCTE, Bangalore on 31.12.2001.

AND WHEREAS, the application was processed and after considering the report of the Visiting Team as well as other relevant materials granted recognition to the institution for offering B.Ed Course with an intake of 100 students from the session 2002-2003 vide order no. 6693 dated 04.04,2003.

AND WHEREAS, the Registrar, Kakatiya University, Warangal vide letter dt. 14.03.2008 drew the attention of Regional Director, SRC and informed that in the process of granting temporary affiliation to the institutions the university conducted inspection and observed that Inadequate temporary building, permanent building not constructed and building is covered with asbestos sheets.

AND WHEREAS, the letter was placed before the SRC in its 157th meeting held on 23rd -24th April 2008. The SRC after careful consideration of all aspects decided to issue show cause notice. Accordingly, a show cause notice was issued on 28.05.2008 to the institution. In response to the notice the applicant institution replied on 21.06.2008.

AND WHEREAS, the reply was placed SRC in its 161st meeting held on 6th -7th August 2008. The SRC has decided and resolved to cause inspection under section 17 to verify the infrastructural and instructional facilities.

AND WHEREAS, SRC-NCTE conducted an inspection of the institution under section 17 of NCTE ACT 1993 on 16.09.2008. The institution had not cooperated in carriying out inspection of institution as per the provisions of NCTE Act. Therefore, the SRC-NCTE in its 165th meeting held on 27th 28th September, 2008 on careful perusal of the original file of the institution, two visiting team report under section 14 & 17, the letter dated 14.03.2008 from the Registrar, Kakatiya University, Warangal to the Regional Director, SRC and the reply dated 21.06.2008 to the show cause notice issued to the institution and other related documents, Act of NCTE 1993, Regulations and guidelines issued from time to time laid on the table, the Regional Committee decided to withdraw the recognition.

AND WHEREAS, a withdrawal Order was issued to the institution on 06.10.2008.

AND WHEREAS, institution preferred an appeal against the withdrawal order dated 06.10.2008. The appellate authority order dated 06.11.2009 considered the appeal and confirmed the order appealed against.

AND WHEREAS, the institution has approached the Hon'ble High Court of Judicature Hyderabad in W.P. No. 1552 of 2010 dated 01.02.2010.

AND WHEREAS, the committee having considered the matter decided to await for the final orders of the court and that copy of the judgement may be sent to Kakatiya University/State Council for Higher Education, A.P.

AND WHEREAS, again court order dated 15.07.2010 has been received in the office of SRC on 07.07.2010 with the direction to inspect the college on payment of inspection fee.

AND WHEREAS, the matter was considered by the committee and it was decided to cause inspection of the institution for B.Ed course, under section 17 of NCTE Act.

AND WHEREAS, inspection of the institution was carried out on 01.09.2010. The inspection report of the institution was placed before SRC in its 196th Meeting held on 15-16 September, 2010 and SRC decided to Continue Recognition.

AND WHEREAS, a Continue of Recognition Order was issued to the institution on 20.09.2010.

AND WHEREAS, the institution has submitted affidavit for Revised Recognition order as per regulation 2014 on 24.01.2015. Accordingly Revised Order was issued to the institution on 06.05.2015.

AND WHEREAS, meantime, the institution has submitted a written representation on 14.01.2016. The SRC in its 298^{th} meeting held on $08^{th}-10^{th}$ January, 2015 considered the institutions written representation and it has decided as under;

1. They have D.El.Ed., D.El.Ed(A.I) and B.Ed.

2. B.Ed and D.El.Ed were shifted without permission

3. Subsequently, D.El.Ed(A.I) was allowed at the 'new' premises after inspection.

4. There has so far been no formal inspection for the shifting. Verify the records check that all requirements have been fulfilled for all the three programmes in accordance with the norms under the 2014 Regulations,

If every thing is all right, collect the 'unpaid' fees, and issue a formal order recognizing the shifting.

NOW THEREFORE, permission is hereby accorded to Rousseau College of Education, Siricilla Revenue Division, No. 3-4-179, Docotors Lane, Head Post Office, Karimnagar District - 505001, Andhra Pradesh to shift its premises to new location/building at Rousseau College of Education, Venkatraopally Village, Narsingapur Post, Boinpally Mandal, Karimnagar District - 505524, Telangana.

Further, in view of the fact that NCTE Regulations (Recognition, Norms and Standards) 2014 are notified, the institution is required to conform to the new requirements as prescribed in NCTE Regulations (Regulation, Norms and Standards), 2014 and submit compliance before 31.10.2015.

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

Also order that a copy of this order be published in the Official Gazette.
