ORDER

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Badvel and Siddout Higher Education Committee, Plot No. 265/15, 15th Street, Badvel Village & Post, Gopavaram mandal, Badvel City, Kadapa District, Pin-516227, Andhra Pradesh had submitted an on-line application to the Southern Regional Committee of NCTE on 01.10.2011 and physical application on 03.10.2011 for grant of recognition for D.El.Ed-AI course of two year duration with an annual intake of 50 students at SBVR Institution of Elementary Teacher Education, Khasara No. 944, 945, 948/1, 2, 947, Plot no. 15, Street no. 15/956, Badvel Village & Post, Gopavaram Taluk, Badvel City, Kadapa District, Pin-516227, Andhra Pradesh

AND WHEREAS, on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc., for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to SBVR Institution of Elementary Teacher Education, Khasara No. 944, 945, 948/1, 2, 947, Plot no. 15, Street no. 15/956, Badvel Village & Post, Gopavaram Taluk, Badvel City, Kadapa District, Pin-516227, Andhra Pradesh for conducting D.El.Ed-AI Course of two year duration with an annual intake of 50 students, thus making an annual intake of 100 students, which includes the existing intake of 50 and additional intake of 50 students from the academic session 2012-2013 under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2009 subject, to fulfillment of the following conditions:

- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
 - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE (Recognition Norms & Procedure) Regulations, 2009.
 - IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
2. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.



3. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
4. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - a) Sanctioned programmes along with annual intake in the institution;
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
 - c) Name of faculty members who left or joined during the last , quarter;
 - d) Names of students admitted during the current session along with qualification, percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The institution shall be free to post additional relevant information, if it so desires
 - j) Any wrong or incomplete information on website shall render the institution liable for withdrawal of recognition
5. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
