**PREAMBLE :**

Sri Veerabhadreshwar Education Trust, Bidar District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sri.Veerabhadreshwar Education Trust D.Ed Institute, Humnabad, Bidar 585330, Karnataka for D.Ed-AI Course on 22.08.2008.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on 17.04.2009 to the applicant institution under provision to Section 15(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

Further, applicant institution had submitted the written representation on 30.04.2009 & 06.05.2009. The said representation was considered by the Regional Committee on 176<sup>th</sup> Meeting held on 27-28 May, 2009 and the Committee decided to refuse recognition.

Accordingly, order of refusal was issued vide No. 14122 dated. 25.06.2009.

The applicant institution preferred appeal under Section 18 of NCTE Act. before NCTE, New Delhi and the Appellate Authority has also confirmed the orders of SRC.

The Appellate Authority vide order dt. 11.09.2009 reversed the order of SRC. Accordingly, letter of intent was issued to the institution on 09.10.2009. The institution submitted its reply vide dated 09.11.2009.

The written representation of the institution was considered by SRC in its 185<sup>th</sup> meeting held on 26<sup>th</sup>-27<sup>th</sup> November 2009 and decided to issue formal recognition.

Hence the order.

**ORDER**

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Shri Veerabhadreshwar Education Trust, Humnabad, Bidar, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting D.ED-AI course with an annual intake of 50 on 22/08/2008.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution/ society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **D.ED-AI** teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/ appointed duly qualified teaching staff as per NCTE norms.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Sri. Veerabhadreshwar Education Trusts D.Ed Institute, Sri.Veerabhadreshwar Education Trust, Humnabad, Bidar 585330, Karnataka** for conducting **D.Ed(Additional Intake)** course of **two years** duration with an annual intake of **100(Hundred)** students which includes the existing intake of 50(Fifty) and an additional intake of 50(Fifty) from the academic session **2009-2010** under clause 7(11) of NCTE (Recognition Norms & Procedure) Regulations, 2007 subject, to fulfillment of following conditions.:

- I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with NCTE should be maintained always. Loan raising or mortgaging of FDRs shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
- III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE( Recognition Norms & Procedure) Regulations,2007.
- IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
