- iv) The institution will ensure that Principal and Five faculty members duly approved by DSERT, Bangalore are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / bodies, State Government etc, as applicable.
- The institution shall submit to the Regional Committee a Self-Appraisal Report at 5. the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant,
- The institution shall maintain & update the Web-site as per provisions of NCTE Regulations.
- If the institution contravenes any of the above conditions or any of the provisions 7. . of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
