ORDER

**WHEREAS**, Muniswamy Technical & Rural Development Educational Society, Kurnool, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of recognition to Sai Sree College of Education, H.No.7-7-13-2, Nehru Nagar, Venkateswara Swamy Temple, Dhone -518222, Kurnool, Andhra Pradesh for Secondary (B.Ed) Course of one year duration with an annual intake of 100 students and was granted recognition on 19.09.2007.

**AND WHEREAS**, on 25.06.2014 a letter received by this office from the Correspondent, Muniswami Technical and Rural Development Education Society, D.No.25/75, Kondapeta, Dhone-518222 Kurnool District Andhra Pradesh which is as under:-

*"We invite to kind attention that in the Ref. Cited we are running "Sai Sree College of Education and Sai Sree Diploma in Education" in the present building. Now we are constructed pucca RCC building in the Sy.No.157/1, Venkat anayani Palli Village, Dhone, Mandal, Kurnool District, as per the NCTE latest norms, with sufficient infrastructure and instructional facilities. The present newly constructed building is situated in a peaceful atmosphere.*

*We enclosed copies of land titles Telugu and English version, land conversion, construction, permissions, building plan for your kind perusal.*

*Hence we request kindly send inspection team and accord permission for shifting the institutions to the building at an early date."*

**AND WHEREAS**, the institution has submitted photocopy of land documents, photo copy of building plan and photo copy of the Notarized copy of change of land use certificate.

**AND WHEREAS**, on 22.01.2015 an affidavit from the Principal Sai Sree college of Education H.No.7-7-13-2, Nehru Nagar, Near Venkateswara Swamy Temple, Dhone -518222 Kurnool District dated 19.01.2015 is received by this office as per revised norms. Revised order was issued to the institution on 12.05.2015.

**AND WHEREAS**, on 15.06.2015 a letter received by this office from the Correspondent, Muniswami Technical and Rural Development Education Society, D.No.25/75, kondapeta, Dhone-518222 Kurnool District Andhra Pradesh (Copy enclosed) is as under:-

*"We invite to your kind attention to the letters cited in the reference(Ref.No.1 NCTE order dated 12.05.2015 & Ref.No;2 NCTE recognition order dated 28.08.2007, Ref.No:3 request of the institution for shifting if premises dated 25.06.2014) we are requesting you as per Ref.1, we have got enough infrastructural and instructional facilities as per NCTE 2014 norms. Now we request you to sanction two basic units in B.Ed course from 2015-16 on wards. We are also going to appoint required teaching faculty as per norms.*

*As per the Ref.2 cited we are very happy that the NCTE has given recognition to our college in 2007-08. The college is running from that year in the present building with all facilities. Now we have already constructed another Pukka RCC building with spacious accommodation in Sy No.157/1, V.Palli Village, Dhone Mandal Kurnool Dist for Teacher Educational Programmes. We have requested you to grant permission for shifting the colleges from present building to new building. As per the ref:3, cited, we have applied for grant of permission for shifting as per the old norms. But no reply is received till today from your office. In this connection we request you that we have got sufficient land and building in the name of society, in the present building. Now we are submitted the necessary and relevant documents for your kind verification. If the shifting process is delayed we request you to kindly permit us to stay in the old building as it has got sufficient accommodation and land on the name of the society as per norms.*

Hence we request you to kindly take early favorable action in this regard"

AND WHEREAS, the Southern Regional Committee in its 290<sup>th</sup> Meeting held during 10<sup>th</sup> and 11<sup>th</sup> July, 2015 considered the matter, letter from the institution dated 15.06.2015, decided and advised Southern Regional Office to:

1. Collect Inspection fee if not already paid.
2. Cause Inspection for shifting.

AND WHEREAS, as per the decision of SRC , a letter seeking all documents pertaining to shifting of premises and inspection fee was sent to the institution on 11.08.2015.

AND WHEREAS, in the meanwhile , the Society had applied for grant of recognition for **Sai Sree M.Ed College ,Plot/Khasra No. 157/1, Venkatanyanipalli Village ,Dhone Taluk and Post Officet ,Dhone Town,** Kurnool District – 518222,Andhra Pradesh for M.Ed course (SRCAPP2680)

AND WHEREAS, SRC while considering the M.Ed for the year 2016-17 decided to conduct composite inspection of the institu tion. Accordingly inspection of the institution was conducted on 08.02.2016 and Inspection report was receiv ed by this office 09.02.2016.


AND WHEREAS, SRC in its 302<sup>nd</sup> meeting held during 9<sup>th</sup> , 10<sup>th</sup> and 11<sup>th</sup> February, 2016 considered the VT Report of the institution and decided as under :-

- " 1. Shifting of B.Ed is permitted'
2. Issue LOI for M.Ed ( 1 unit) after obtaining proof of application for NAAC certification for B.Ed course ."

NOW THEREFORE, permission is hereby accorded by SRC to Sai Sree College of Education, H.No.7-7-13-2, Nehru Nagar, Near Venkateswara Swamy Temple , Dhone -518222, Kurnool, Andhra Pradesh to shift its premises to the new location / building at **Sai Sree College of Education, Plot/Khasra No. 157/1, Venkatanyanipalli Village ,Dhone Taluk and Post Office ,Dhone Town, Kurnool District -518 222,Andhra Pradesh**

If the institution contravenes any of the conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
