**PREAMBLE :**

The **Neelakanteshwar Vidyavardhak Samsthe, Hosur, Bailhongal-591102, Belgaum District, Karnataka** had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to **Shri Neelakanteswara Teacher Training Institute, Vidyanagar, baihongal District-591102, Belgaum District, Karnataka** for **D.Ed-Additional Intake Course** on 23.12.2005.

After considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, had noted that the applicant institution does not fulfill the requirements and issued a notice on **25.09.2007** to the applicant institution under provisio to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.

Further, applicant institution had submitted the written representation on **26.10.2007**. The said representation was considered by the Regional Committee on 148th Meeting of SRC held on 27-28 November, 2007. and the Committee decided to refuse recognition.

Accordingly, order of refusal was issued vide Ir.No.15855 dated. 10.12.2007.

The applicant institution preferred appeal under Section 18 of NCTE Act, before NCTE, New Delhi. The Appellate Authority considering the appeal passed an order vide.F.No.89-27/2008 dated. 10.07.2008 reversing the decision of SRC.

The NCTE Headquarters Vide Letter dated 04.07.2008 directed this office to issue the recognition orders to the institution wherever reversal of decision is there and place the decision before SRC Subsequently. Accordingly, Conditional Recognition letter was issued to the institution on 29.07.2008. The institution has submitted reply with necessary annexures and staff profile. Accordingly reply was placed before 162<sup>nd</sup> Meeting of SRC held on 20-21 August, 2008. SRC decided to issue Unconditional recognition.

Hence the order.

**ORDER**

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 **Sri Neelakanteshwar Vidyavardhak Samsthe, Hosur, Bailhongal-591102, Belgaum District, Karnataka** has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting **D.Ed-Additional Intake** course with an additional0 intake of **20** on 23.12.2005.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution/ society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary** teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/ appointed duly qualified teaching staff as per NCTE norms.
3. NOW, THEREFORE, in exercise of the powers vested under Section 15(3) (a) of the NCTE Act, 1993, the Southern Regional Committee, NCTE hereby grants recognition to **Shri Neelakanteswara Teacher Training Institute, Vidyanagar, baihongal District-591102, Belgaum District, Karnataka** for conducting **D.Ed-Additional Intake** of two years duration with an annual intake of **50(Fifty)** students which includes the existing intake of **30(Thirty)** and an additional intake of **20(Twenty)** from the academic session **2008-09** under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions
  - I. The endowment fund of Rs.5 lakhs and reserve fund of Rs.3 lakhs kept in joint account with SRC, NCTE should be maintained always. Loan raising or Mortgaging of FDRs shall not be done.
  - II. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - III. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations,2007.
  - IV. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc, as applicable.
5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
  - (i) Copy of the Application Form
  - (ii) Land and Building Particulars
  - (iii) Staff Profile
  - (iv) Recognition letter
  - (v) Information for having fulfilled the norms & standard and other required conditions.

7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.
