ORDER

WHEREAS, **Sri Siddeshwara Education Society, Bijapur District, Karnataka** had applied for grant of recognition to **Shri Siddeshwar Education Society's D.Ed College, Loni(B.K), Indi Taluk, Bijapur District-586204, Karnataka** for D.Ed-AI Course of **two** years duration under Section 14(I) of the NCTE Act, 1993 to the Southern Regional Committee, NCTE.

2. AND WHEREAS the competent authority had constituted a Visiting Team to visit the institution and the visiting team had since submitted its report.
3. AND WHEREAS, in its 126th Meeting of SRC held on 20-23 February, 2007. The Southern Regional Committee after considering the report of the visiting team as well as other relevant materials furnished by the applicant institution, is satisfied that the applicant institution does not fulfill the requirements and issued a notice on **14.03.2007** to the applicant institution under proviso to Section 14(3)(b) of the NCTE Act, 1993, thereby giving an opportunity to the said applicant institution to make a written representation in this behalf.
4. AND WHEREAS, the applicant institution had submitted its written representation and the same was considered by SRC and decided to cause Re-inspection. Accordingly, re-inspection of the institution was carried out on **16.05.2007**. The re-inspection report was considered by SRC in its 134th Meeting of SRC held on 29-31 May, 2007. along with videography, other relevant documents and came to the conclusion that recognition to the said institution be refused for the following reasons:

(i) The Additional space in building and labs. equipment, Library books are not adequate for additional intake

5. NOW, THEREFORE recognition to **Shri Siddeshwar Education Society's D.Ed College, Loni(B.K), Indi Taluk, Bijapur District-586204, Karnataka** for the **D.Ed-AI** Course in terms of section 14(3)(b) of the NCTE Act, 1993, is hereby refused.
6. If the institution is not satisfied by the above Order they can prefer an appeal to the council in terms of section 18 of NCTE Act, 1993.
7. Also ordered that a copy of this order be published in the Official Gazette.
