**Preamble:**

Shri Veerabhadreshwara Rural Teachers Training Institute, Bellary, Karnataka has submitted application to SRC on 07.01.2008 for D.Ed - additional intake course. Inspection of the institution was carried out on 14.03.2009. The inspection report of the institution was placed before SRC in its 173<sup>rd</sup> meeting held on 20-22 April 2009. As the facilities created by the institution was not as per NCTE norms, a notice was issued to the institution on 03.05.2009.

Institution submitted its written representation on 11.05.2009. The SRC in its 176<sup>th</sup> meeting held on 27-28 May 2009 considered the written representation submitted by the institution and decided to refuse recognition. Accordingly, order of refusal was issued to the institution vide order dated 25.06.2009.

The institution preferred an appeal dated 03.07.2009 and the Appellate Authority vide order dated 08.10.2009 has reversed the orders of SRC. Accordingly, LCI was issued to the institution on 06.11.2009. The representation of the institution received on 20.11.2009 was placed before SRC in its 180<sup>th</sup> meeting held on 26-27 November 2009 and decided to issue notice. Accordingly, notice was issued to the institution on 01.12.2009. The institution has submitted its written representation on 14.12.2009 and the same was placed before SRC in its 187<sup>th</sup> meeting held on 29-30 December 2009. SRC considered the written representation and decided to issue formal recognition order.

Hence the order.

**ORDER**


WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Shri. Shivananda Bharati Educational Society, Saundatti, taluk - 591 102, Bellary District, Karnataka has submitted an application to the Southern Regional Committee of NCTE for grant of recognition for conducting D.Ed-Additional Intake course with an additional intake of 80 students on 07.01.2008.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith, the affidavit and the input received from the visiting team in the form of report and videography, institution fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the D.Ed - Additional Intake teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to **Shri.Veerabhadreshwara Rural Teacher Training Institute, Shri.Shravananda Bharati Educational Society, Hutkundi, Bellary - Bangalore High Way, Bellary-581102, Karnataka** for conducting D.Ed-Additional Intake course of two year duration with an annual intake of 100 (One hundred) students which includes the existing intake of 50 (Fifty) students and an additional intake of 50 (Fifty) students from the academic session 2009-2010 under clause 7(1) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
- I. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
  - II. The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(12) of the NCTE(Recognition Norms & Procedure) Regulations,2007.
  - III. The institution shall ensure that the required number of academic staff for conducting the course is always in position.
  4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable.
  5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
  6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
    - (i) Copy of the Application Form
    - (ii) Land and Building Particulars
    - (iii) Staff Profile
    - (iv) Recognition letter
    - (v) Information for having fulfilled the norms & standard and other required conditions.
  7. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

In terms of Section 14(1) of the NCTE Act, 1993 Shri Shivanand Bharati Education Society, Saundatti, Belgaum District, Karnataka had submitted an application to the Southern Regional Committee of NCTE for grant of recognition to SVR Teacher Training Institute, Halakundi, Bellary District-583102, Karnataka for Elementary(D.Ed) Course of two and half years duration from the academic session 2004-05 with an annual intake of 50 students.


2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:

- a. The institution has acquired the land for setting up the teacher education institution.
- b. The institution has constructed the building for conducting the course on the above mentioned land.
- c. The institution has created an Endowment Fund of Rs.5 lakhs and a Reserve Fund of Rs. 3 Lakhs.
- d. The institution has selected the Principal and five teachers for the said course and the list of faculty members has been approved by the Director, DSERT, Bangalore.

3. Now, therefore, in exercise of the powers vested under Section 14(2)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants recognition to SVR Teacher Training Institute, Halakundi, Bellary District-583102, Karnataka for Elementary (D.Ed) course of two and half years duration from the academic session 2004-2005 with an annual intake of 50 students subject to fulfillment of the following.

- a. The institution will ensure that Principal and five faculty members duly approved by DSERT are in position for an intake of 50 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately and in any case not later than one month from the date of commencement of the course.

- b. The institution shall, within one month of the receipt of recognition order, convert the Endowment fund account into a joint account to be operated along with an official of the Southern Regional Committee.
- c. The institution shall shift to its own premises / building within three years from the date of recognition, (in case the course is started in rented premises).
- d. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the Directorate of State Educational Research and Training (DSERT) to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the Provisions of Section 17(1) of the NCTE Act, 1993.


