## PREAMBLE:

Sidheequiya Teacher Training Institute, Sidheeqyiya Islamic Centre, Annakayam, Annakayam Post, Munduparamba via, Malappuram District, Pin – 676509, Kerala has made application for grant of recognition for Elementary course of two year duration to Southern Regional Committee on 01.01.2003.

On scrutiny of the application it was found that application was complete and essential documents as required under regulations were submitted.

Accordingly, visiting team was deputed on 27.03.2004 to assess the infrastructural and instructional facilities available in the institution. The visiting team report was placed before 77<sup>th</sup> meeting of SRC held on 29-30 July 2004 and SRC decided to issue notice on 18.08.2004 stating the following deficiencies : -

- Adequate space for classroom, Hall and Laboratories is not available.
- The instructional facilities in library, lab are not adequate.
- The teaching staff with B.Ed. qualification do not possess the required experience as per norms.
- Land titles are not in the name of the institution / Trust as per norms.

The written representation of the institution dated 27.08.2004 was placed before 78<sup>th</sup> meeting of SRC held on 31<sup>st</sup> August 2004 and 1<sup>st</sup> September 2004 and SRC decided to reject the proposal for starting Elementary course. Hence, Rejection orders were issued on 23.09.2004 with the above mentioned deficiencies.

The applicant institution preferred appeal before NCTE, New Delhi against the rejection order issued by this office dated.23.09.2004. The Appellate Authority considered the appeal and passed order 27.12.2004 and the council remands back the case to SRC-NCTE for necessary action. Accordingly a visiting team was deputed on 11.02.2005 to assess the infrastructural and instructional facilities and the claims made by the institution. The visiting team report was placed before 90<sup>th</sup> meeting of SRC held on 17-18 March 2005. SRC decided to issue notice on 31.03.2005 with the following deficiency:

Laboratories are not adequately equipped.

Written representation dt.25.04.2005 for the notice was placed before 94<sup>th</sup> meeting of SRC held on 24.07.2005 and SRC decided to depute a team to verify the claims made by the institution. Accordingly a visiting team was deputed to the institution on 24.08.2005. The visiting team report was placed before 100<sup>th</sup> meeting of SRC held on 23-24 September 2005 and SRC decided to accord recognition.

Hence the following order

## ORDER

In terms of Section 14(1) of the NCTE Act, 1993 Sidheequiya Teacher Training Institute, Sidheeqyiya Islamic Centre, Annakayam, Annakayam Post, Munduparamba via, Malappuram District, Pin – 676509, Kerala had submitted an application to the Southern Regional Committee of NCTE for grant of recognition for starting Elementary course with an intake of 50 students of two year duration from the academic session 2004-2005.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
  - a) The institution has acquired the land for setting up the teacher education institution.
  - b) The institution has created an Endowment Fund of Rs.5.00 Lakhs and a Reserve Fund of Rs.2.94 Lakhs.
  - c) The institution has selected the Principal / Head and **five** teachers for the said course.
- 2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Sidheequiya Teacher Training Institute, Sidheequiya Islamic Centre, Annakayam, Annakayam Post, Munduparamba via, Malappuram District, Pin 676509, Kerala for Elementary course of two year duration from the academic session 2005-2006 with an annual intake of 50 students subject to fulfillment of the following.
  - a) The institution will ensure that <u>six</u>\_exclusive faculty members (Principal/Head and fifteen teachers) are in position for an intake of <u>50</u> students and a report to this effect shall be sent to the Committee immediately and in any case before commencement of the admissions.
  - b) The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Regional Committee.

c) The institution shall shift to its own premises within three years from the date of recognition (in case the course is started in temporary premises).

- d) The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations.
- Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC / University / State Government etc.,
- 4. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University for the appointment of faculty members and the statement of annual accounts duly audited by a Chartered Accountant.
- 5. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
