**SUB: Shifting of Smitha Pre-Primary Teacher Training Institute (PPTTI) from Seenai Nagar, Iringole to Aluva, Ernakulam District, Kerala - regarding.**

Preamble :

The Manager, Smitha Pre-primary Teacher Training Institute, Seenai Nagar, Iringole has approached the Southern Regional Committee, National Council For Teacher Education, Bangalore for approval of shifting of the institution from Seenai Nagar, Iringole to Aluva, Ernakulam District, Kerala. The State Government of Kerala has also accorded permission to shift the institution from Iringole to Aluva.

A visiting team was deputed by the SRC-NCTE to Aluva, Ernakulam District on 27.05.2002, to verify the infrastructure and other facilities provided by the institution at the new location. The visiting team has submitted its report and the same was placed before Southern Regional Committee.

And whereas upon consideration of the visiting team report and other documents furnished by the institution, SRC decided to permit the institution to shift from Seenai Nagar, Iringole to Aluva, Ernakulam District from the academic session 2002-2003.

Hence the order.

## ORDER

In exercise of the powers vested under Section 14(3)(a) of the National Council For Teacher Education (NCTE) Act, 1993, the Southern Regional Committee grants recognition to **Smitha Pre-primary Teacher Training Institute, "Gandhi Marg", Chembarkey, S.Vazhakulam Post, Aluva – 683105, Ernakulam District, Kerala** for **Pre-primary course** of one year duration from the academic session **2002-2003** with an annual intake of **30** and accorded permission to shift from Seenai Nagar, Iringole to Aluva, Ernakulam District Kerala, subject to fulfilling the following conditions:

1. The certificate given by the State of Kerala will be valid for employment within Kerala only and that the duration and admission criteria are those that exist in the State of Kerala prior to the promulgation of the NCTE Act. The institution is permitted to conduct the course of one year duration upto 2005 only. Thereafter the course has to be switched over to two years as per NCTE norms.
2. The institution should maintain teacher pupil ratio of 1:12 as per NCTE norms.

3. All such teachers already appointed who do not fulfil the NCTE norms shall acquire the qualifications as per the NCTE norms.
4. The institution shall ensure library, laboratories and other instructional infrastructure as per the NCTE norms.
5. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the State Government.
6. Tuition fee and other fees will be charged from the students as per the norms of the State Government till such time NCTE regulations in respect of fee structure come into force.
7. Curriculum transaction, including practical work / activities, should be organised as per the norms and standards for the course and the requirements of the examining body.
8. Teaching days including practice teaching should not be less than the number fixed in the NCTE norms for the course.
9. The institution shall continue to fulfil the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Performance Appraisal Report at the end of each academic year. The performance appraisal report should inter alia give the extent of compliance of the conditions indicated above.

If **Smitha Pre-primary Teacher Training Institute, "Gandhi Marg", Chembarkey, S.Vazhakulam Post, Aluva - 683105, Ernakulam District, Kerala** contravenes the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder or fails to fulfill the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.
