WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Sri Anjani Putra Educational Society, Satram Street, Darsi (P) Prakasam District, Andhra Pradesh had applied on 31.12.2001 for grant of recognition to Smt. Mannaru Yasodamma Memorial B.Ed College Sy. No.458/1, 458/3, Addanki Road, 14th Block Darsi Prakasam District-523247, Andhra Pradesh for B.Ed course of one year duration.

AND WHEREAS, the recognition was granted to the institution for B.Ed course of one year duration on 13.10.2003 with an intake of 100 students from the academic session 2003-04.

AND WHEREAS, on 20.10.2014, and 27.10.2014, a staff list dated 25.09.2014 was received by this office from the Registrar, Acharya Nagarjuna University, Nagarjunanagar-522510, Andhra Pradesh.

AND WHEREAS, the SRC in its 275th meeting held during 1st & 2nd December, 2014 considered the matter and decided to defer the matter for consideration with respect to the new Regulations that are being notified by the NCTE (Hqrs). The Committee further, advised Southern Regional Office to put up in the next meeting.

AND WHEREAS, on 31.12.2014, letters were issued to all the existing institutions regarding notification of new Regulations, 2014 and seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015. The institution submitted affidavit on 31.01.2015 for offering B.Ed course with an intake of 100 students.

AND WHEREAS, the SRC in its 276th meeting held on 7th-9th January, 2015 considered the matter and decided to issue provisional recognition orders to the existing institutions which had submitted affidavit for compliance of NCTE Regulations, 2014.

AND WHEREAS, the SRC in its 279th meeting held on 01st February, 2015, considered the letters received from the Registrar, Acharya Nagarjuna University-regarding Affiliations -Verification of Teaching Staff and decided to issue show cause notice for appointment of Principal and Art Education Lecturer in accordance with new norms.

AND WHEREAS, before issuance of Show cause notice, as per the website information, the institution submitted reply on 09.02.2015, enclosing a copy of approved list of Principal and Arts Education Lecturer.

AND WHEREAS, the SRC in its 283rd meeting held on 2nd – 3rd March, 2015 considered the matter and "Noted".

AND WHEREAS, the institution submitted shifting proposal for B.Ed & D.El.Ed on 29.04.2015 along with processing fee.

AND WHEREAS, the SRC in its 284th meeting held on 09th -10th April, 2015, considered the matter and decided to cause inspection.

AND WHEREAS, as per the decision of SRC, inspection intimation was sent to the institution and VT members on 20.04.2015. The Inspection of the institution was conducted on 25.04.2015 and VT report along with documents and CD received on 02.05.2015.

AND WHEREAS, the SRC in its 287th meeting held on 20th May, 2015 considered the matter and decided to permit shifting to new premises.

AND WHEREAS, as per the decision of SRC, orders for Shifting of premises and Revised order (common order) was issued to the institution on 29.05.2015 from the academic session 2015-16 with an intake of two units of 50 students each in B.Ed course.

AND WHEREAS, the SRC in its 314th meeting held on 27th to 28th May 2016, decided as for cases of B.Ed (2 Units) in the existing institution, where RPRO, has been issued, we have to cause inspection to check adherence to the 2014 Regulations. This action will have to be completed by July 2016 so that revised Formal Recognition can be issued w.e.f. 2016-17 to enable them to make admission in time.

AND WHEREAS, as per the decision of SRC, Inspection intimation was sent to the institution on 14.06.2016. The institution submitted representation on 04.07.2016 requesting for waiving of inspection.

AND WHEREAS, the SRC in its 318th meeting held on 08th-09th August 2016 considered the matter and decided to issue new FR for B.Ed (2 units) with effect from 2016-2017 at the new site.

NOW THEREFORE, this order is issued granting recognition to the institution Smt. Mannaru Yasodamma Memorial B.Ed College, Sy. No.458/1, 458/3, Addanki Road, 14th Block Darsi Prakasam District-523247, Andhra Pradesh for running B.Ed course of two years duration with an intake of 100 students (two units of 50 students each) from the academic session 2016-17 subject to fulfillment of the following conditions:

- I. The Endowment fund of Rs.5 lakhs and Reserve fund of Rs.7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II. The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014, as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 2. Further, the institution is required to fulfil all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University / Body, the State Government etc, as applicable.
- 3. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 4. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter—alia, the details of the institution, its location, name of the programme with intake; availability of physical infrastructure, such as land, building, office, classrooms, and other facilities or amenities; instructional facilities, such as laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programmes along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left or joined during the last, quarter:
 - d. Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities:
 - g. Facilities added during the last quarter;
 - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter,
 - i. The affidavit with enclosure submitted along with application.
 - j. The institution shall be free to post additional relevant information, if it so desires.
 - k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

- 5. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 6. The institution shall make available the list of students admitted on its official website.
- 7. The institution shall fill the information on GIS Portal on the NCTE website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made or issued thereunder, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisions of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this order be published in the official Gazette.
