The Committee in its 205<sup>th</sup> meeting held on 18-19 May 2011 considered the reply of the institution Dt. 21.4.2011, VT report of the institution, and other related documents along with the original file of the institution for shifting to new/permanent premises and decided to permit shifting to new premises.
