WITHDRAWAL ORDER**

WHEREAS, recognition was granted to the institution namely Sri Vidya Vihar College of Physical Education, Khasara No. 21/part and 22/part, Plot No. 6-114/2, NTPC cerci Street, Annojiguda Village, Ghatkesar Post, Taluk & City, Rangareddi District-500088, Telangana run by Rashtriya Vidya Kendra Plot No. 6-114/2, NTPC Circle Road Annojiguda Village, Ghatkesar Post, Taluk & City Rangareddi District-500088, Telangana vide SRC (NCTE) order no. F.SRO/NCTE/SRCAPP14696/B.P.Ed/TS/2016-2017/84180 dt. 12.04.2016 for conducting B.P.Ed. course of two year duration with an annual intake of (one basic unit) of 100 (two sections of 50 students each).

AND WHEREAS, the institution vide letter dated 21.12.2018 requested for closure of B.P.Ed programme. In response the SRC sent a letter dated 07.01.2019 to the institution requesting therein to submit an application in the prescribed Proforma alongwith the following documents:-

1. Application for closure as per format.
2. Reason(s) for closing the programme with supporting documents.
3. Resolution of the Society/Trust/Company for closure of the programme.
4. NOC of the Affiliating Body.
5. Letter from affiliating body about completion of programme by students of the current batch.
6. Proof of settlement of all claims of Faculty/Staff along with copy of Pan card of Institution.

AND WHEREAS, the institution vide letter dated 20.06.2019 submitted its reply. The SRC in its 377th meeting held on 03rd – 04th July, 2019 considered the matter and decided as under;

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

As requested by the institution the recognition accorded to the B.P.Ed. programme is hereby withdrawn as per NCTE provisions. Therefore it is decided to withdraw B.P.Ed programme of the Institution as per provisions of the NCTE Act, 1993. Accordingly withdrawal order be issued.

However, the Reserve fund and Endowment fund will be refunded on the submission of the following: -

- a) NOC from the affiliating body.
- b) Resolution of the management to the affect for closure of B.P.Ed.programme.
- c) NOC from the staff/faculty.


NOW, THEREFORE, in exercise of the powers vested u/s 17(1) of the NCTE Act, 1993, the Southern Regional Committee hereby withdraws recognition of **Sri Vidya Vihar College of Physical Education, Khasara No. 21/part and 22/part, Plot No. 6-114/2, NTPC cerci Street, Annojiguda Village, Ghatkesar Post, Taluk & City, Rangareddi District-500088, Telangana** for conducting **B.P.Ed** programme of two years duration with an annual intake of 100 students (one units) on the grounds mentioned above.

Further, the institution offers and affiliating body is hereby informed about the following provision of Section 17(4) of NCTE Act:-

"If an institution offers any course of training in teacher education after the coming into force of the order Withdrawing Recognition under sub-section (1) or where an institution offering a course or training in teacher education immediately before the appointed day fails or neglects to obtain recognition or permission under this Act, the qualification in teacher education obtained pursuant to such course or training of after undertaking a course or training in such institution, shall not be treated as a valid qualification for purpose of employment under the Central Government, any State Government or University, or in any school, College or other Educational Body aided by the Central Government or any State Government."

Further, if the institution is not satisfied with the Order, it may prefer an Appeal under Section 18 of the NCTE Act, 1993 through "online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of issue of this order. The guidelines for filing appeal may be seen on NCTE's website.
